Resolution 12-47 Amending the *2011-2014 TIP* by increasing the cost of the Midtown Redevelopment Transportation Infrastructure Improvements project (TIP # H07-73-MN1, PIN 475525)

WHEREAS,

1. The *2011-2014 Transportation Improvement Program* (TIP) identifies those projects to receive federal transportation funding within the seven-county GTC TIP area;
2. The City of Rochester proposes the following change to the *2011-2014 TIP* :
 - a. Midtown Redevelopment Transportation Infrastructure Improvements (TIP # H07-73-MN1, PIN 475525) – *Increase* the total cost from \$14,832,500 (\$2,577,173 Federal) to \$15,316,500 (\$3,421,150 Federal); *Increase* the Detailed Design phase from \$1,601,000 (\$1,286,173 Federal) to \$2,085,000 (\$1,363,600 Federal); *Increase* the Federal share of the Construction phase from \$1,127,000 to \$2,057,850; *Defer* the Construction phase from FFY 2012 to FFY 2013; *Defer* the Construction Inspection phase from FFY 2012 to FFY 2013;
3. The source of additional Federal funds is a grant from the U.S. Department of Commerce Economic Development Administration;
4. The proposed change is described on the attached Project Detail Sheet;
5. The proposed change does not require a new Conformity Determination;
6. The timing of this project is such that an amendment of the *2011-2014 TIP* is now called for; and
7. The Council is satisfied that this amendment of the *2011-2014 TIP* is within the limits of reasonably expected funding resources and is consistent with the Long Range Transportation Plan.

WHEREAS,

1. The *2011-2014 Transportation Improvement Program* (TIP) identifies those projects to receive federal transportation funding within the seven-county GTC TIP area;
2. The City of Rochester proposes the following change to the *2011-2014 TIP*:
 - a. WHEREAS,

1. The *2011-2014 Transportation Improvement Program* (TIP) identifies those projects to receive federal transportation funding within the seven-county GTC TIP area;
2. Monroe County proposes the following change to the *2011-2014 TIP* :
 - a. Edgemere Drive Bridge over Round Pond Outlet (TIP # B05-04-MN1, PIN 475391) – *Increase* the total cost from \$1,148,291 (\$918,633 Federal) to \$1,176,291 (\$941,033 Federal); *Add* a supplemental Construction Inspection phase at a cost of \$28,000 (\$22,400 Federal);
