Attachment A - TIP Amendments: Highway

1. Proposed Council Resolution 20-48 (Amending the *2020-2024 TIP* by changing the limits of the NYSDOT Bridge Deck Preventive Maintenance (10 Locations) project) (TIP # B17-14-R43, PIN 480649) – NYSDOT

Change the Project Name to "NYSDOT Bridge Deck Preventive Maintenance (10 9 Locations);

Change the Project Limits to "BINs 1072391, 1072392, 1048571, 1048572, 1021540, 4445280, 1024610, 1043420, <u>and</u> 1048790, and 1071170"; *Decrease* the Federal Share from \$5,431,424 to \$5,291,035.

The source of Federal funds is the National Highway Performance Program. Resolution 20-7 previously added one new bridge project and increased the Federal Share to account for reduced match on the Interstate.

During review of the Bridge Rehabilitation Justification Report, a step of Final Design, the NYSDOT Office of Structures required bridge rail be upgraded to meet MASH standards for deck preventive maintenance treatments that have a ten-year or greater life cycle. To replace the bridge rail, bridge fascia is required to be sound concrete or replaced to ensure proper anchorage. Route 390 NB & SB over Round Pond Creek (BIN 1072391 and BIN 1072392) require such upgrades and the bridge fascia are not in good condition, estimated at \$400,000.

Sutton Road over I-390 (BIN 1071170) would also require railing upgrade but due to the length of this bridge, the cost to replace the bridge rail and place a deck treatment would be greater than the cost for deck replacement, and was deemed a non-ideal use of funds. NYSDOT requests to add bridge rail replacement to this project for BIN 1072391 & BIN 1072392 and remove BIN 1071170 from the project to offset the cost of the added rail work.
