This report was prepared by the Genesee/Finger Lakes Regional Planning Council for the Genesee Transportation Council under the Unified Planning Work Program (Task # 4220).

Mission Statement

The Genesee/Finger Lakes Regional Planning Council (G/FLRPC) will identify, define, and inform its member counties of issues and opportunities critical to the physical, economic, and social health of the region. G/FLRPC provides forums for discussion, debate, and consensus building, and develops and implements a focused action plan with clearly defined outcomes, which include programs, personnel, and funding.

Abstract

This report provides information on the issuance of building permits in 2018 to identify areas of growth within the Genesee-Finger Lakes Region (G-FL Region) that might require transportation planning and service modifications. The G-FL Region is comprised of Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, and Yates Counties. The report analyzes the number of permits issued, total square footage, and total value for buildings for each municipality within the region as well as within the Metropolitan Planning Area (MPA). The MPA is comprised of Monroe County plus the adjacent developed areas of Livingston, Ontario, and Wayne counties. The analysis looks at the following categories and respective subcategories: "residential" (single-family, two-family, three or four-family, five-or-more family, mobile/manufactured homes); "industrial;" "commercial" (offices/banks, retail/service, service stations, hotels/motels); "community service" (hospitals/health facilities, schools/churches, public works/safety, utilities); and "not elsewhere classified."

Introduction

The Genesee Transportation Council (GTC) provides annual funding for the *Regional Land Use Monitoring Report* (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee-Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The *Regional Land Use Monitoring Report* includes residential, industrial, commercial, community service, and mixed use building permit data for all nine counties in the G-FL Region. This includes subdivision applications and permitted demolitions, as well as rezoning and conversion applications and the number of upgrades and remodels per municipality. The categories (and associated subcategories) for building permit data are as follows:

- Residential (single-family, two-family, three-or-four-family, five-or-more-family, and mobile/manufactured homes)
- Industrial
- Commercial (offices/banks, retail/service/restaurants, service stations, hotels/motels)
- Community Service (hospitals/medical facilities, schools, government buildings)
- Mixed Use (both vertical and horizontal buildings encompassing multiple uses such as residential, commercial, and retail in one building or complex)
- Not Elsewhere Classified
- Subdivision Applications (containing 4 or more lots)
- Rezoning/Conversions (including number of lots and total acres)

- Upgrades/Remodels (includes all additions, alterations, repairs, decks, pools, sheds, etc.)
- Demolitions by permit (for Residential, Industrial, Commercial, and Other structures)

A five-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the five-year period. This time-series analysis is based on this year's and the four previous years' Land Use Monitoring Reports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

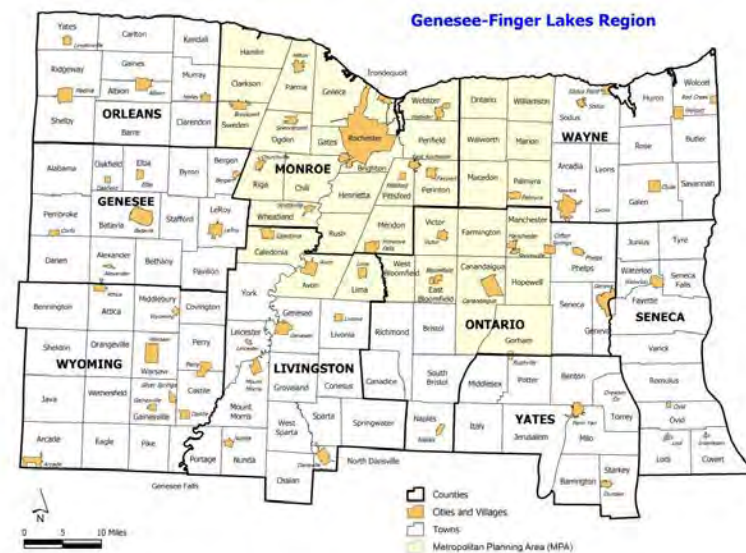
The MPA consists of Monroe County plus the adjacent developed areas of Livingston, Ontario, and Wayne counties. Table 1 represents the municipalities that, along with Monroe County, comprise the MPA.

An analysis of the collected data on the number, value, and size of buildings permitted in 2020 is provided for each county as well as the MPA.

The data on permitted building activities are provided in appendices at the end of this report for the reader to use for their own needs and analysis.

Methodology

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties, these officials were often the code or zoning enforcement officers and in some cases were the municipal clerks. In Seneca and Wyoming Counties, building permit application approval and inspection are the responsibility of the respective county building departments and thus these departments provided the relevant data. In Monroe County, the Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2021 asking for the requested data. The initial survey was followed up with reminder e-mails and telephone calls to those municipalities that had yet to respond.

G/FLRPC received 81% of the region's responses from the survey that was administered. This represents 153 of the 188 reporting municipalities within the nine-county G-FL Region. Additionally, 15.9% of the region's data was pulled from either the Census Bureau or the New York State Department of State 2020 Annual Uniform Code Report. Over all, data was gathered from 97.3% of the region, accounting for 183 municipalities out of 188 having data available to use in this report.

Administering the 2020 Land Use Monitoring Report Survey in 2021 saw a continued decline in responses from pre-pandemic numbers. Alternate data sources were sought to supplement residential building permit data, which lead to the use of the

Census Bureau Building Permit data and the NYS DOS 2020 Annual Uniform Code Report.

The Census Bureau provides a voluntary Building Permit Survey. This survey and subsequent database "provides data on the number of new housing units authorized by building permits. Data are available monthly, year- to- date, and annually at the national, state, selected metropolitan area, county and place levels. The data are from the Building Permits Survey." The categories used by the Census Bureau align closely with the G-FL Regional Survey, such as such as "Single Family", "Two Family," "Three-Four Family," and "Five or more Family". While the Census Bureau Database does not align completely nor provide data on all regional municipalities, it helped fill in the gaps from the primary G/FLRPC survey source.

The Uniform Code Report is filled out annually by most municipalities. Its data very loosely overlaps with the topics of the G/FLRPC Land Use Monitoring Report Survey. The Residential building permit categories cover "One-family dwellings, two-family dwellings, and townhouses, new construction" whereas the G-FL Regional Survey separates residential building permits into individual categories such as "Single Family", "Two Family," "Three-Four Family," and "Five or more Family", "Mobile or Manufactured Housing". This was used as a tertiary data source when the other two had no data.

The survey requested information on the number of permits issued, and the total square footage and total value for buildings in the defined categories and associated subcategories. The total square footage and total value is intermittently reported based on municipal records. In addition,

the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the “Other” category. In some cases descriptions were not provided. The analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey were as follows:

“Include permits for NEW construction of PRINCIPLE STRUCTURES permitted in the 2020 calendar year.
New Report Remodels/Upgrade permits separately.
Please do separate surveys for each municipality you represent and answer ALL questions in each section.”

For each of the nine counties, there is a discussion of permitted building activity in 2020 by county and county maps of residential units permitted in 2020 by municipality. Maps 10 – 18 represent each County’s residential permits. Map 19 represents the 5-year residential permitted units in the nine-county G-FL Region. Map 20 represents residential permits for the region in 2020 by municipality. Map 21 represents residential units in the nine-county G-FL Region by municipality in 2020. Data of industrial, commercial, community service building permits, and remodel/upgrade permits issued in 2020 are presented on maps of the nine-county G-FL Region. See Maps 22-25.

The information and data provided for permitted building activity in Monroe County and the remaining portion of the MPA follows the same format. Maps 26 and 27 present the number of residential permits, and permitted residential units respectively in the MPA region in 2020. Maps 28 through 30 present the number of permitted industrial, commercial, and community service buildings in the MPA in 2020. Map 31 shows the distribution of

residential building permits among the Transportation Analysis Zones (TAZ) within the MPA outside of Monroe County.

The residential data for MPA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2011 through 2020. The number of permits issued for industrial and commercial buildings from 2011 to 2020 in the MPA outside of Monroe County is also presented and discussed in the same manner.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in, and for the MPA, outside Monroe County are presented in Appendices A through J. The Appendices are as follows:

2020 County Building Permit Analysis

Genesee County

Residential Permits:

- Thirty nine (39) residential building permits representing 95 units were reported in Genesee County in 2020. The largest number of permits, at 13, was reported in the Town of Batavia. The largest number of units was in the City of Batavia with 58 units. The Town of Pembroke reported the second most permits with 7 and the Town of Batavia reported the second most permitted units with 13.
- Thirty six (36) permits were for single family or mobile/manufactured housing while three permits were for multi-family buildings representing 59 units.
- *Map 10 shows the number of residential unit permits in Genesee County in 2020.*

Industrial Permits:

- One (1) industrial building permit was reported in 2020 in the Town of Batavia.
- *Map 22 shows the number of industrial building permits by municipality in the G-FL Region in 2020.*

Commercial Permits:

- There was one (1) commercial buildings permit reported in 2020, in the Town of Stafford.
- *Map 23 shows the number of commercial building permits by municipality in the G-FL Region in 2020.*

Community Service Permits:

- There were no community service building permits reported in 2020.
- *Map 24 shows the number of community service building permits by municipality in the G-FL Region in 2020.*

Mixed Use Permits:

- There was one (1) mixed-use permits reported in 2020 in the Town of Alexander.

Not Elsewhere Classified Permits:

- There were no permits reported that would be included as not elsewhere classified for Genesee County municipalities in 2020.

Subdivision Applications:

- There was one (1) subdivision application in 2020 with four lots in the City of Batavia.

Rezoning/Conversion Applications:

- There were no rezoning application in 2020.

Demolition Permits:

- Twenty (20) residential demolition permits and six other demolition permits for a total of 26 permitted demolitions were reported in Genesee County in 2020.

Remodel/Upgrade Permits:

- There was a total of 1,082 remodel permits in 2020 in Genesee County. The City of Batavia reported 405 permits and the Town of Batavia reported 130 permits.

Livingston County

Residential Permits:

- Eighty eight (88) Residential building permits representing 89 units were reported in Livingston County in 2020. The Town of Avon had the largest number of permits at 26 permits and units and the Town of Geneseo had 16 permits. The Town of Livonia was third with 14 units.
- Eighty seven (87) permits were for single family or mobile/manufacture housing with one permit for two-family structure.
- *Map 11 shows the number of residential units permits in Livingston County in 2020.*

Industrial Permits:

- There were three industrial building permits reported in 2020, two in the Town of York and one in the Town of Caledonia.
- *Map 22 shows the number of industrial building permits by municipality in the G-FL Region in 2020.*

Commercial Permits:

- Six (6) commercial building permits were reported in Livingston County in 2020. The Town of Livonia had three permits with the Town of Avon having two.
- *Map 23 shows the number of commercial building permits by municipality in the G-FL Region in 2020.*

Community Service Permits:

- There were no community service building permits reported in 2020.
- *Map 24 shows the number of community service building permits by municipality in the G-FL Region in 2020.*

Mixed Use Permits:

- There were no mixed use permits reported in 2020.

Not Elsewhere Classified Permits:

- One hundred and twelve (112) permits that did not correspond to the above-described categories were issued and included as not elsewhere classified. Ninety five permits were issued in the Village of Geneseo and nine permits were in the Town of York.

Subdivision Applications:

- There were zero subdivision applications in 2020.

Rezoning/Conversion Applications:

- There were no rezoning applications issued in 2020.

Demolition Permits:

- Twenty eight (28) residential demolition permits and six "other" demolition permits were reported in Livingston County in 2020.

Remodel/Upgrade Permits:

- The number of residential units permitted in 2020 in the MPA show 778 units in the City of Rochester in Monroe County with the next highest found in the Town of Henrietta with 278 units, the Town of Irondequoit with 270 units and the Town of Penfield with 263 units, all in Monroe County.
- The top municipality in Ontario County was the Town of Farmington with 152 permits representing 125 units.
- The top municipality in Wayne County was the Town of Ontario with 50 residential permits representing 36 units in 2020.
- The top municipality in Livingston County was the Town of Avon with 26 residential permits for 26 units in 2020.

Single Family Residential:

- The top three municipalities with single family/mobile/manufactured home permits in 2020 were the Town of Greece (98), the Town of Henrietta (88), and the Town of Webster (73) in Monroe County.
- The top three municipalities with single family/mobile/manufactured home permits outside of Monroe County in 2020 were the Town of Farmington (107) and the

Town of Canandaigua (38) in Ontario County and the Town of Ontario (34) in Wayne County.

Multi-Family Residential:

- The top three municipalities permitting multi-family residential units in 2020 are the City of Rochester, Monroe County, with 33 permits representing 720 units, the Town of Henrietta, Monroe County, issued 20 permits for 190 units and the Town of Farmington, Ontario County, issued 18 permits for 45 units.
- The top three municipalities' permitted units for multi-family residential in 2020 are the City of Rochester, Monroe County, with 720 units, the Town of Irondequoit, Monroe County, with 265 units, and the Town of Penfield, Monroe County with 224 units.

Subdivisions:

Transportation Analysis Zones (2020)

Addresses of residential building permits issued in 2020 were collected from municipalities located within the Metropolitan Planning Area (MPA) outside of Monroe County. Addresses were then geo-coded using Geographic Information System software to determine which Transportation Analysis Zone (TAZ) each permit was located in. Some addresses did not geocode accurately and were manually moved to the approximate location based on a review of aerial imagery. And not all municipalities reported addresses for the building permits. As the transportation analysis zones tend to follow road boundaries this should not impact the accuracy of the number of permits per transportation analysis zone.

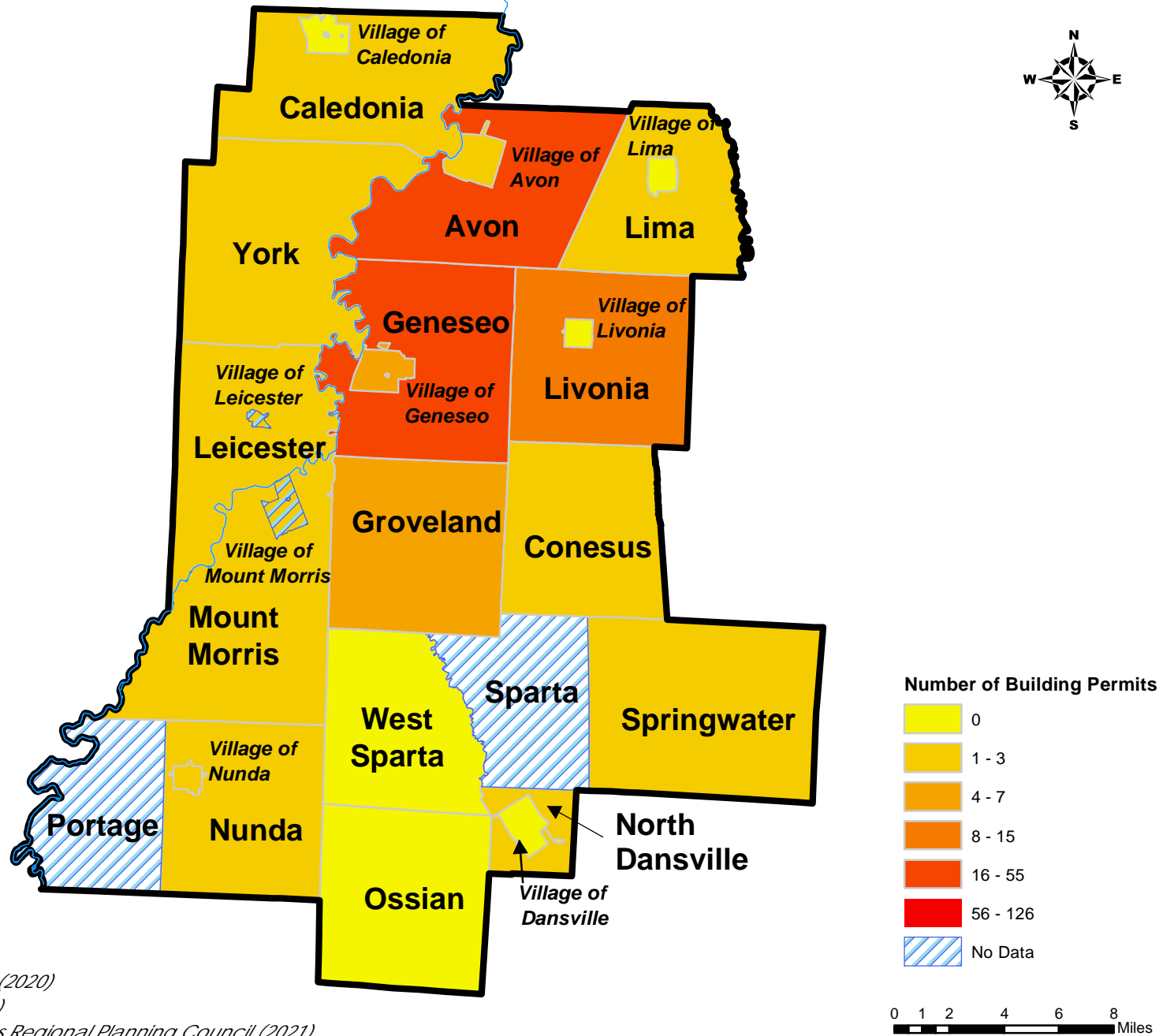

Number of Residential Building Permits in Ontario County (2020)



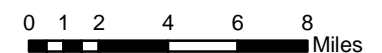
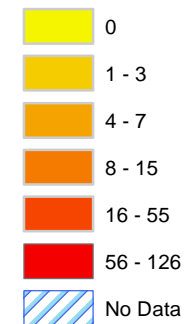

Five Year Analysis of Residential Units in the Genesee/Finger Lakes Region (2016-2020)



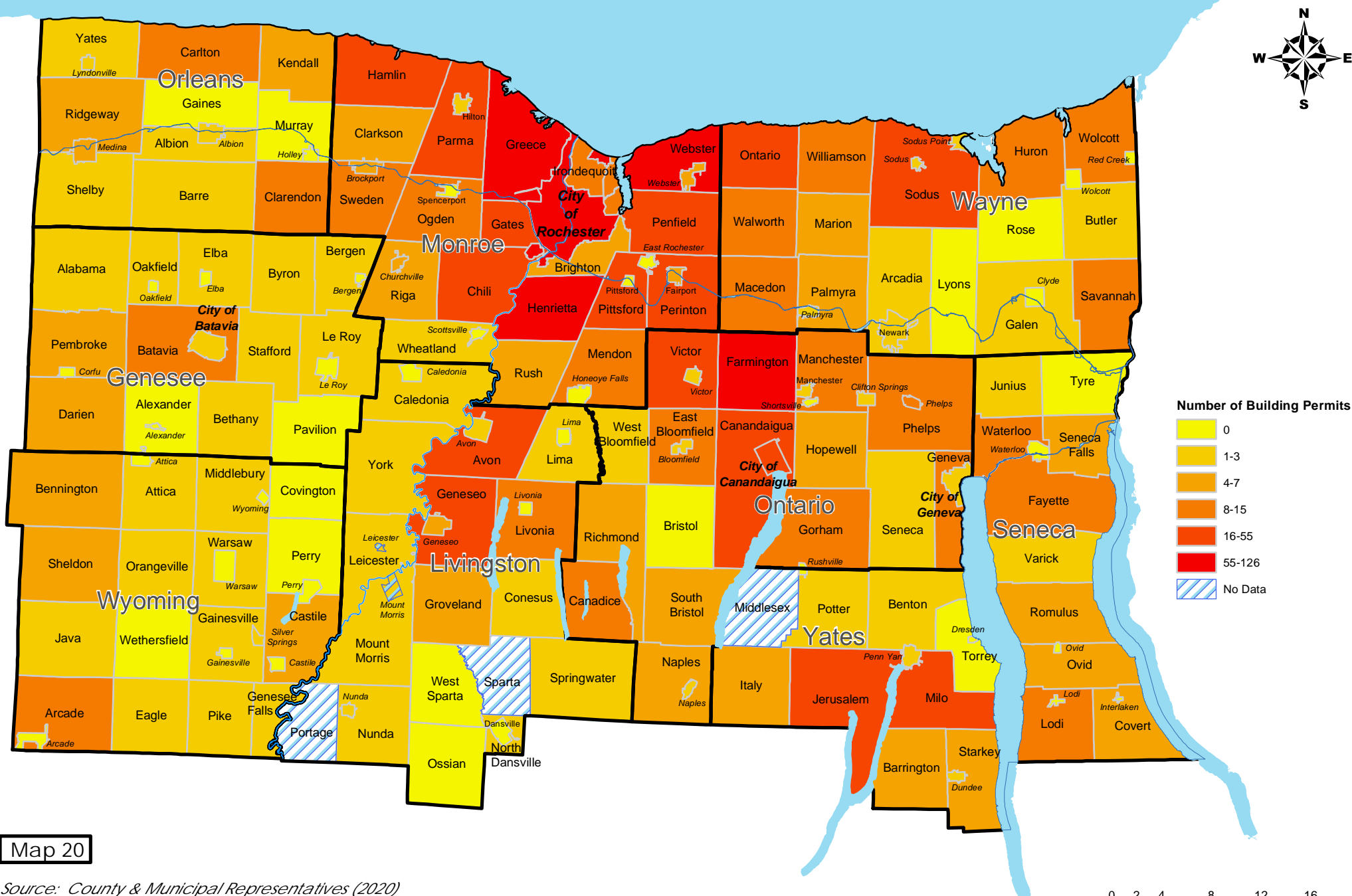

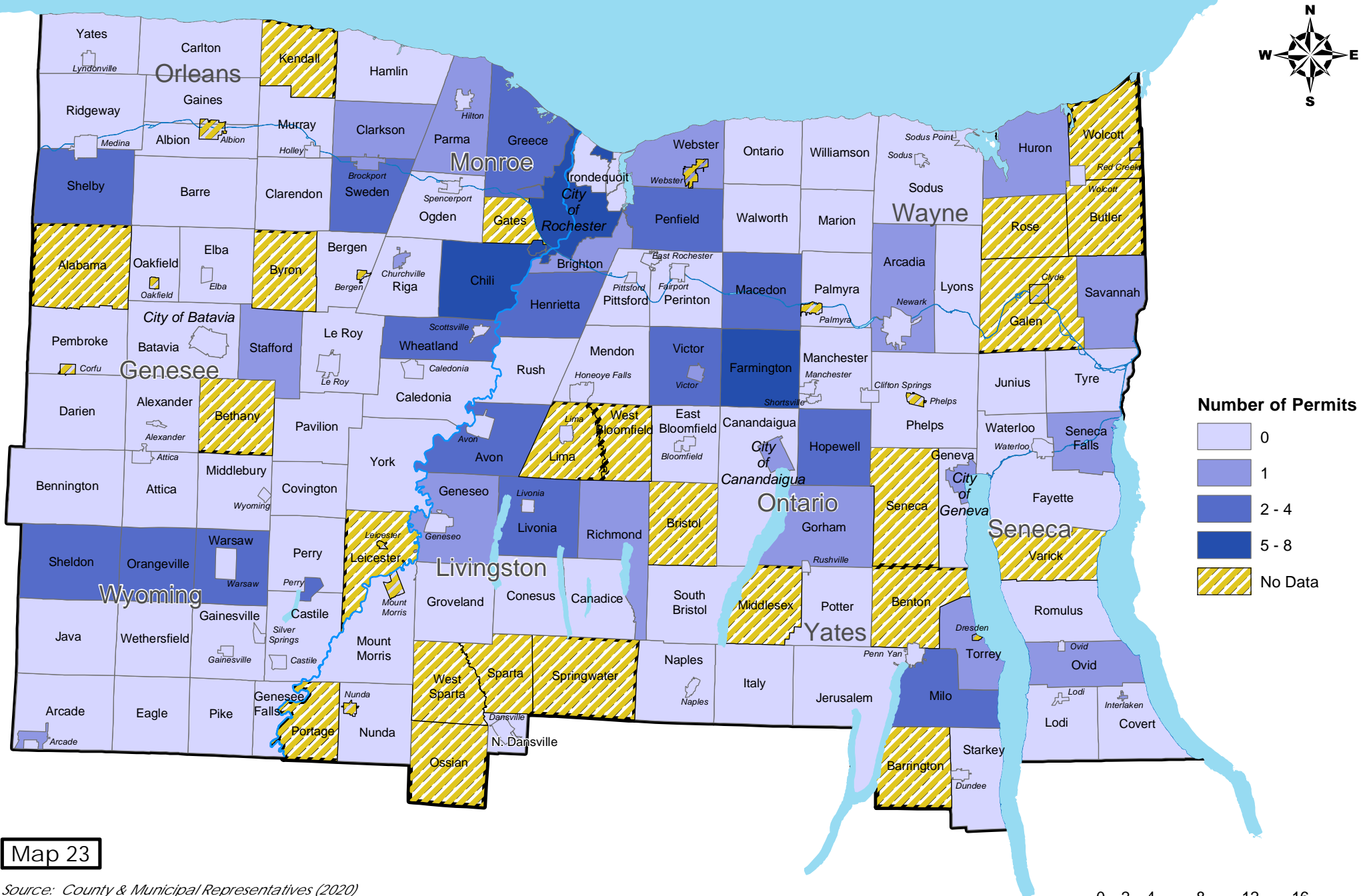
