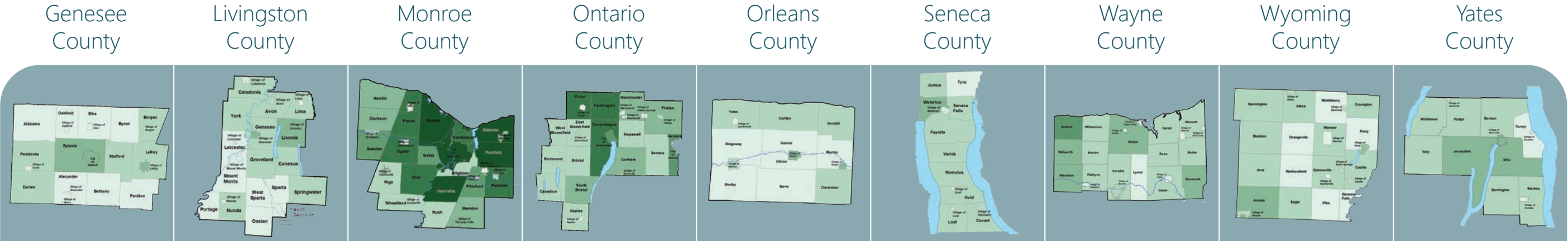

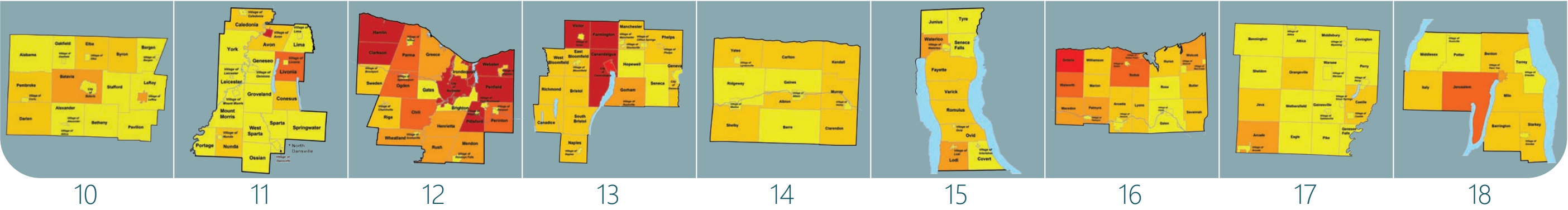

M A P S - B Y C O U N T Y

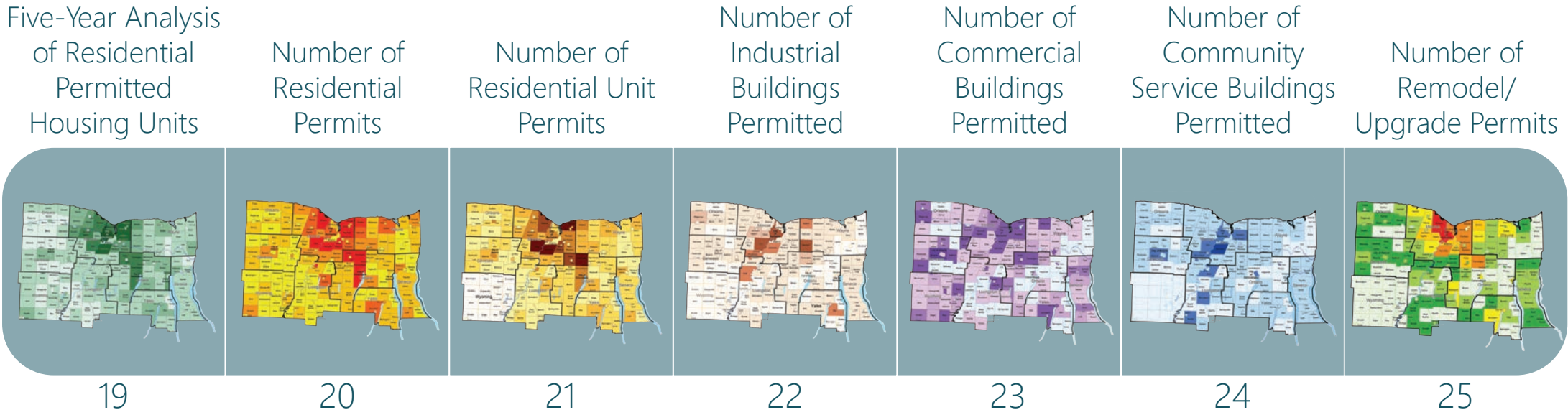
Five-Year Analysis

(2018-2022)



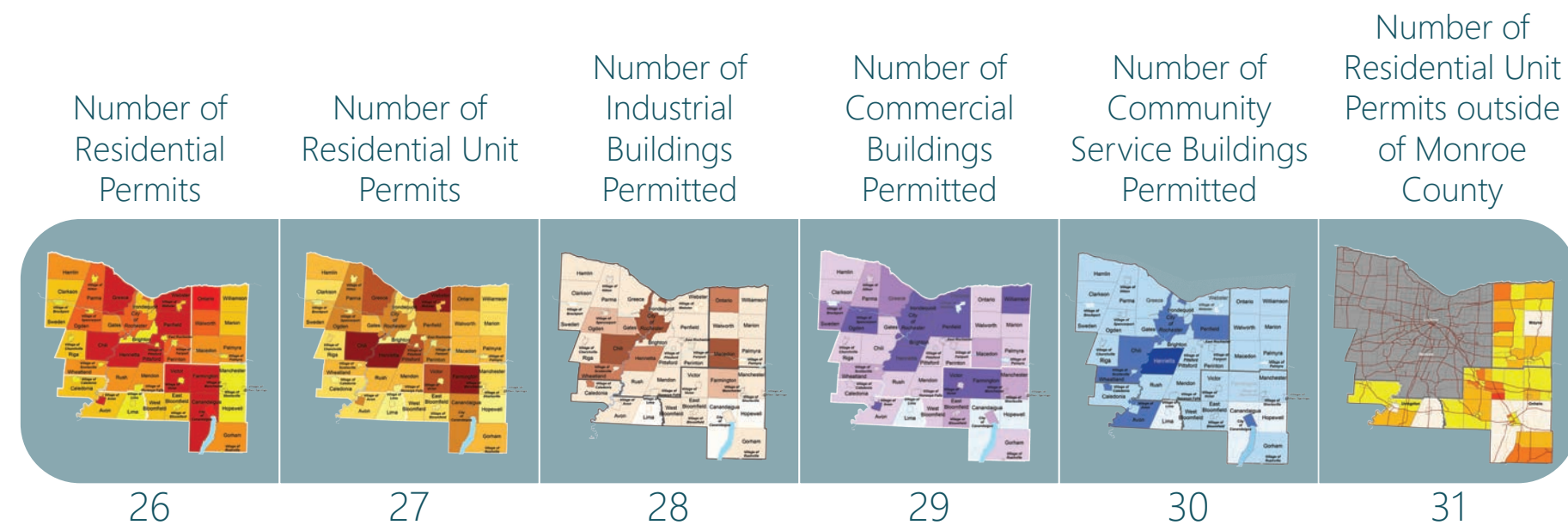

1. Introduction

The Genesee Transportation Council (GTC) provides annual funding for the Regional Land Use Monitoring Report (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee/Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The Regional Land Use Monitoring Report includes residential, industrial, commercial, community service, and mixed use building permit data for all nine counties in the G-FL Region. This includes subdivision applications and permitted demolitions, as well as rezoning and conversion applications and the number of upgrades and remodels per municipality. The categories (and associated subcategories) for building permit data are as follows:

Community Service



Mixed Use

A five-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the five-year period. This time-series analysis is based on this year’s and the four previous years’ Land Use Monitoring Reports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC). The MPA consists of Monroe County plus the adjacent developed areas of Livingston, Ontario, and Wayne counties. Table 1 represents the municipalities that, along with Monroe County, comprise the MPA. An analysis of the collected data on the number, value, and size of buildings permitted in 2022 is provided for each county as well as the MPA. The data on permitted building activities are provided in appendices at the end of this report for the reader to use for their own needs and analysis.

2. Methodology

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties, these officials were often the code or zoning enforcement officers and in some cases were the municipal clerks. In Seneca and Wyoming Counties, building permit application approval and inspection are the responsibility of the respective county building departments and thus these departments provided the relevant data. In Monroe County, the Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2022 asking for the requested data. The initial survey was followed up with reminder e-mails and telephone calls to those municipalities that had yet to respond. Once it was determined data was not available from the municipalities, building permit was sourced first from the Census Bureau Building Permit Report and from the NYS DOS 2022 Annual Uniform Code Report if not other sources were available.

G/FLRPC received 76% of the region's responses from the survey that was administered. This represents 143 of the 188 reporting municipalities within the nine-county G-FL Region. Additionally, 19.5% of the region's data was pulled from either the Census Bureau or the New York State Department of State 2022 Annual Uniform Code Report. Overall, data was gathered from 95% of the region, accounting for 179 municipalities out of 188 having data available to use in this report.

The US Census Bureau Building Permit Data Report categories are closely matched to the G/FLRPC Land Use Monitoring Re-port Survey in residential categories. The Uniform Code Report is filled out annually by most municipalities. Its data very loosely overlaps with the topics of the G/FLRPC Land Use Monitoring Report Survey. The Residential building permit categories cover "One-family dwellings, two-family dwellings, and townhouses, new construction" and "Other residential occupancies, new construction." There is one question on the form that covers all categories under "Nonresidential buildings, new construction." And there are four questions covering the one "Upgrades/Repairs" section of the G/FLRPC Land Use Survey. These are as follows "One-family dwellings, two-family dwellings, and townhouses. Repairs, alterations, etc. of existing", "Other residential occupancies, repairs, alterations, etc. of existing", "Nonresidential buildings, repairs, alterations, etc. of existing", and "All other permits

(pools, sheds, decks, plumbing, HVAC, etc)." The data reported on the G/FLRPC survey and the NYS DOS Uniform Code report did not always report or reflect the exact same numbers.

The survey requested information on the number of permits issued, and the total square footage and total value for buildings in the defined categories and associated subcategories. The total square footage and total value is intermittently reported based on municipal records. In addition, the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the "Other" category. In some cases descriptions were not provided. The analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey were as follows:

"Include permits for NEW construction of PRINCIPLE STRUCTURES permitted in the 2022 calendar year. **New** Report Remodels/Upgrade permits separately. Please do separate surveys for each municipality you represent and answer ALL questions in each section."

For each of the nine counties, there is a discussion of permitted building activity in 2022 by county and county maps of residential units permitted in 2022 by municipality. Maps 10 – 18 represent each County's residential permits. Map 19 represents the 5-year residential permitted units in the nine-county G-FL Region. Map 20 represents residential permits for the region in 2022 by municipality. Map 21 represents residential units in the nine-county G-FL Region by municipality in 2022. Data of industrial, commercial, community service building permits, and remodel/upgrade permits issued in 2022 are presented on maps of the nine-county G-FL Region. See Maps 22-25.

The information and data provided for permitted building activity in Monroe County and the remaining portion of the MPA follows the same format. Maps 26 and 27 present the number of residential permits, and permitted residential units respectively in the MPA region in 2022. Maps 28 through 30 present the number of permitted industrial, commercial, and community service buildings in the MPA in 2022. Map 31 shows the distribution of residential building permits among the Transportation Analysis Zones (TAZ) within the MPA outside of Monroe County.

The residential data for MPA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2012 through 2022. The number of permits issued for industrial and commercial buildings from 2012 to 2022 in the MPA outside of Monroe

County is also presented and discussed in the same manner.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in, and for the MPA, outside Monroe County are presented in Appendices A through J. The Appendices are as follows:

3. 2022 County Building Permit Analysis



Residential Permits

There were 66 residential building permits representing 70 units were reported in Genesee County in 2022. The largest number of permits, at 26, was reported in the Town of Batavia. The largest number of units was also in the Town of Batavia with 30 units. The Village of Bergen reported the second most permits and units with 18 permits.

There were 62 permits for single family or mobile/manufactured housing while 4 permits were for multi-family buildings representing 8 units.

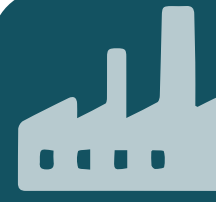

Commercial Permits

There were 8 commercial buildings permit reported in 2022, in the Town of Batavia with 4 permits and 2 reported in the Town of Darien.

Industrial Permits

There was 1 industrial building permit reported in 2022 in the Town of Bergen.

Community Service Permits

There were 2 community service building permits reported in 2022; 1 each in the City of Batavia and Village of Corfu.

There was 1 mixed-use permit reported in the Town of Pembroke in 2022.



Not Elsewhere Classified

There were 648 permits reported that would be included as not elsewhere classified for Genesee County municipalities in 2022.

There were 617 permits reported in the City of Batavia and 23 reported in the Town of Darien.



Subdivision Applications

There were 3 subdivision applications in 2022.



Rezoning/Conversion Applications

There were 6 rezoning applications in 2022.



Demolition Permits

There were 10 residential demolition permits, and 13 other demolition permits for a total of 23 permitted demolitions were reported in Genesee County in 2022.



Remodel/Upgrade Permits

There was a total of 1,133 remodel permits in 2022 in Genesee County. The City of Batavia reported 617 permits and the Town of Batavia reported 91 permits.



Residential Permits

There were 119 residential building permits representing 127 units were reported in Livingston County in 2022. The Town of Avon had the largest number of permits with 36 permits for 36 units and the Towns of Geneseo and Livonia had each 16 permits. The Town of Geneseo permitted 51 residential units.

Additionally, 13 multi-family permits were reported representing 48 units.

Map 11 shows the number of residential units permits in Livingston County in 2022.



Not Elsewhere Classified

There were 160 permits that did not correspond to the above-described categories were issued and included as not elsewhere classified.

There were 154 permits were issued in the Town of Livonia and 6 permits were in the Town of York.



Commercial Permits

There were 6 commercial building permits were reported in the County. The Town of Livonia with 3 permits and the Town of Avon had 2 permits.

There were 20 residential demolition permits were reported in Livingston County in 2022.

There were 6 "other" demolition permits were reported in Livingston County in 2022.

Subdivision Applications

There were 4 subdivision applications in 2022.



Remodel/Upgrade Permits

There were 680 remodel/upgrade permits issued in Livingston County in 2022. The Town of Livonia reported 154 permits and the Town of Avon issued 109 permits.



Residential Permits

Municipalities in Monroe County reported 661 residential building permits for a total of 1,445 residential units in 2022.

The largest number of permits reported was in the Town of Penfield (106) and the Town of Webster with 87 followed by the Town of Greece with 73.

The Town of Henrietta reported the highest number of residential units at 656 with the Town of Perinton reporting 192 units.

A total of 595 permits were for single family residences (490) and mobile/manufactured homes (105).

A total of 66 multi-family unit permits were reported for 879 units in the county

Map 12 shows the number of residential unit permits in Monroe County in 2022.



Commercial Permits

There were 45 commercial building permits reported in Monroe County. The Town of Greece reported 8 permits, the Town of Parma reported 7 permits, and the Town of Penfield had 6 permits.

Industrial Permits

There were 8 industrial building permits reported in the County, 2 in the Town of Chili and the Town of Wheatland each.

Community Service Permits

There were 8 permits reported for community service buildings in the County, with 4 in the Town of Wheatland and 2 in the Town of Henrietta.

Map 24 shows the number of community service building permits by municipality in the G-FL Region in 2022.



Mixed-Use Permits

No mixed-use permits were reported in Monroe County in 2022.



Not Elsewhere Classified

There were 126 permits were reported with 47 in the Village of Spencerport as highest, that did not correspond to the above-described categories and are identified as not elsewhere classified.



Subdivision Applications

There were 12 subdivision applications in 2022 comprising 464 lots and 13 application approvals. 3 of the applications were in the Town of Gates.



Rezoning/Conversion Applications

There were 19 total rezoning applications in 2022 for a total of 70 acres.



Demolition Permits

There were 116 residential demolition permits were reported in Monroe County in 2022 with 83 other demolition permits issued.



Remodel/Upgrade Permits

Monroe County saw a total of 10,707 remodel/upgrade permits issued. The City of Rochester reported 2,843 permits and the Town of Greece had 2,257. The Town of Irondequoit had 1,338 permits.



Residential Permits

Ontario County municipalities reported 325 residential structures permitted in 2022 totaling 373 units.

The Town of Farmington reported the most permits with 83 permits.

The Town of Victor reported the second most with 74 permits.

There were 262 permits total. For single family there were 233 and mobile/manufactured homes had 29.

There were 51 permits were issued for multi-family residences in 2022 totaling 284 units.

Commercial Permits

96 commercial building permits were reported in Ontario County. 84 permits were in the Town of Victor and 4 in the Town of East Bloomfield.

Industrial Permits

There were 15 industrial building permits reported in Ontario County in 2022, with 10 in the Town of Victor.

Map 22 shows the number of industrial building permits in the G-FL Region in 2022.



Community Service Permits

There were 4 permits reported in the County. The Town of Victor had 2 and the City of Canandaigua and Town of Farmington had 1 permit each.

Map 24 shows the number of community service building permits by municipality in the G-FL Region in 2022.



Mixed-Use Permits

There were no mixed-use permits reported for 2022 in Ontario County.



Not Elsewhere Classified

There were 48 permits reported that did not correspond to the other categories.

The Town of Naples had the most at 27 permits with the Village of Naples reporting 21 permits.



Subdivision Applications

There were 18 subdivision applications with 204 lots, and 15 approved applications in 2022.



Rezoning/Conversion Applications

There were 3 rezoning applications in the Town of Farmington in 2022.



Demolition Permits

There were 49 residential demolition permits and 22 other demolition permits were reported in Ontario County in 2022.



Remodel/Upgrade Permits

Ontario County saw a total of 2,547 remodel/upgrade permits issued. The Town of Farmington had 756 and 255 were in the Town of Victor.



Residential Permits

There were 43 residential building permits reported in Orleans County in 2022. The data sources for the permits issued did not capture the number of units represented. The Town of Clarendon issued 17 permits with the Town of Carlton issuing 15 permits.

There were 12 permits in the Town of Carlton reported for multi-family residences through the NYS Uniform Code 1203 form which does not specify how many units are represented.

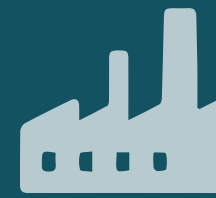
Map 14 shows the number of residential unit permits in Orleans County in 2022.

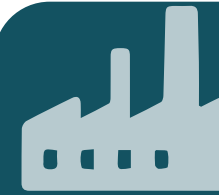

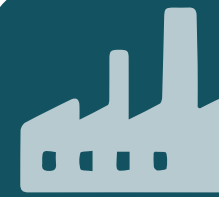

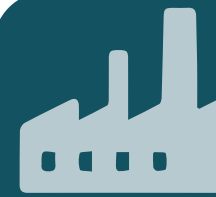

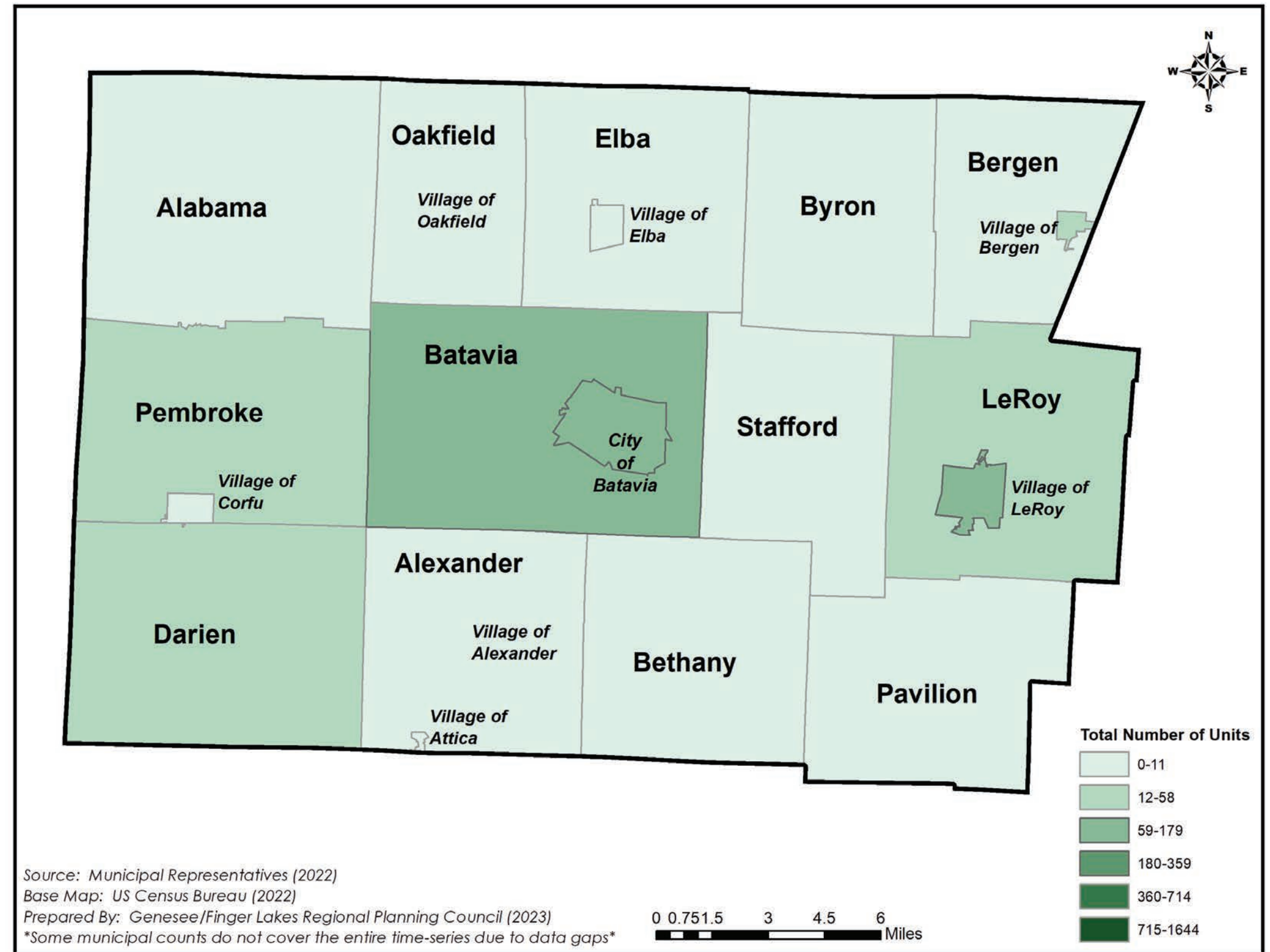

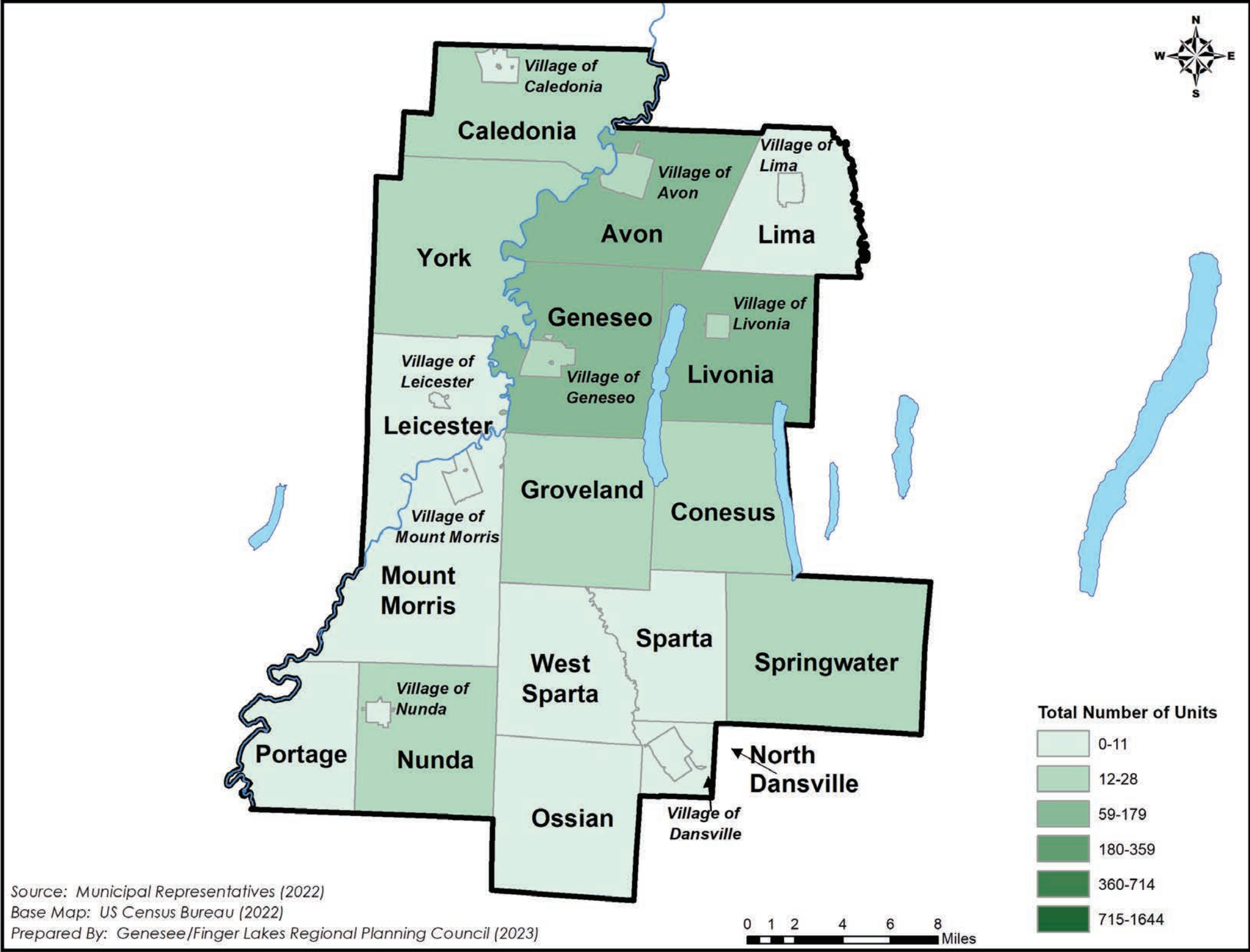

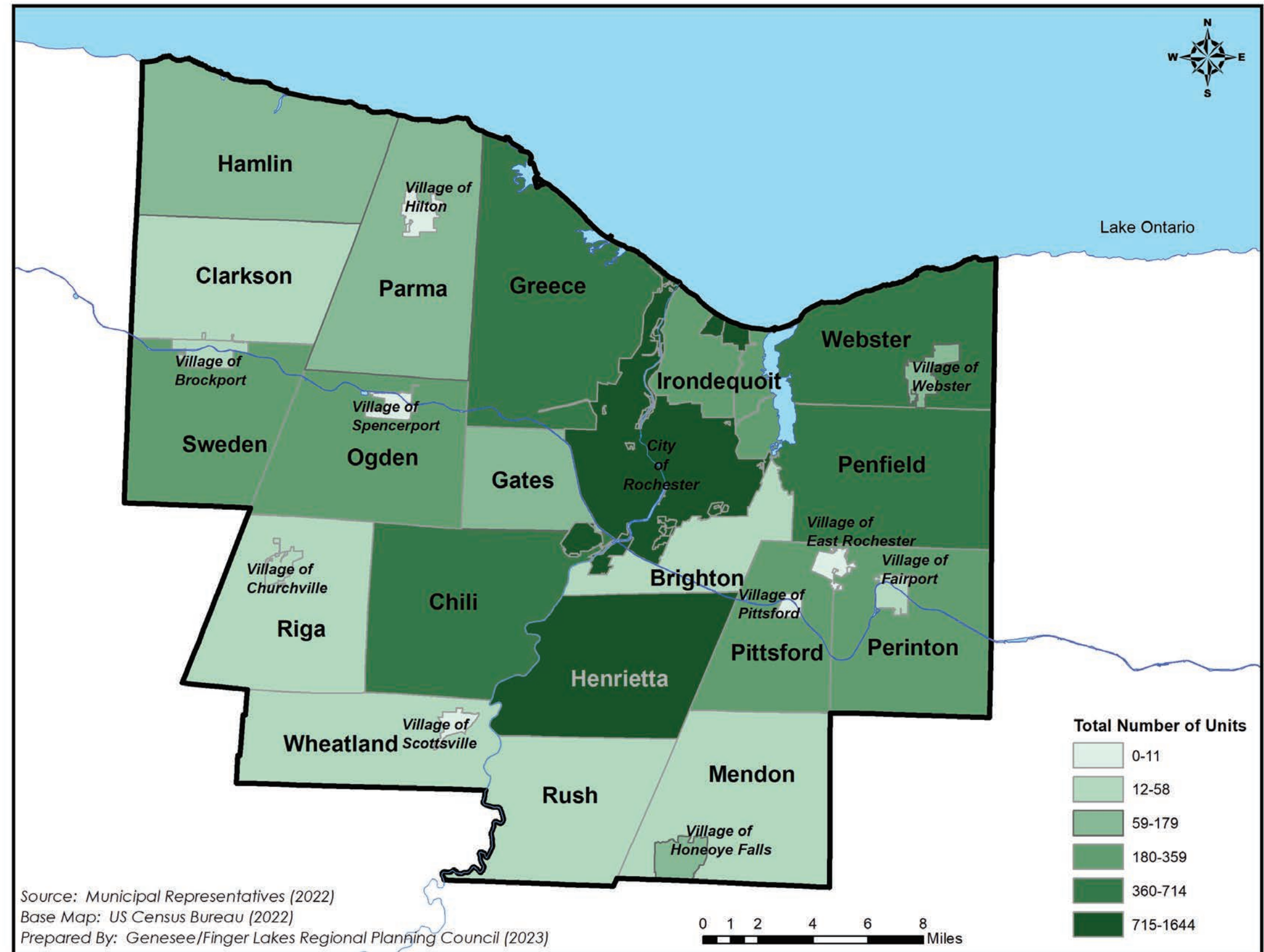

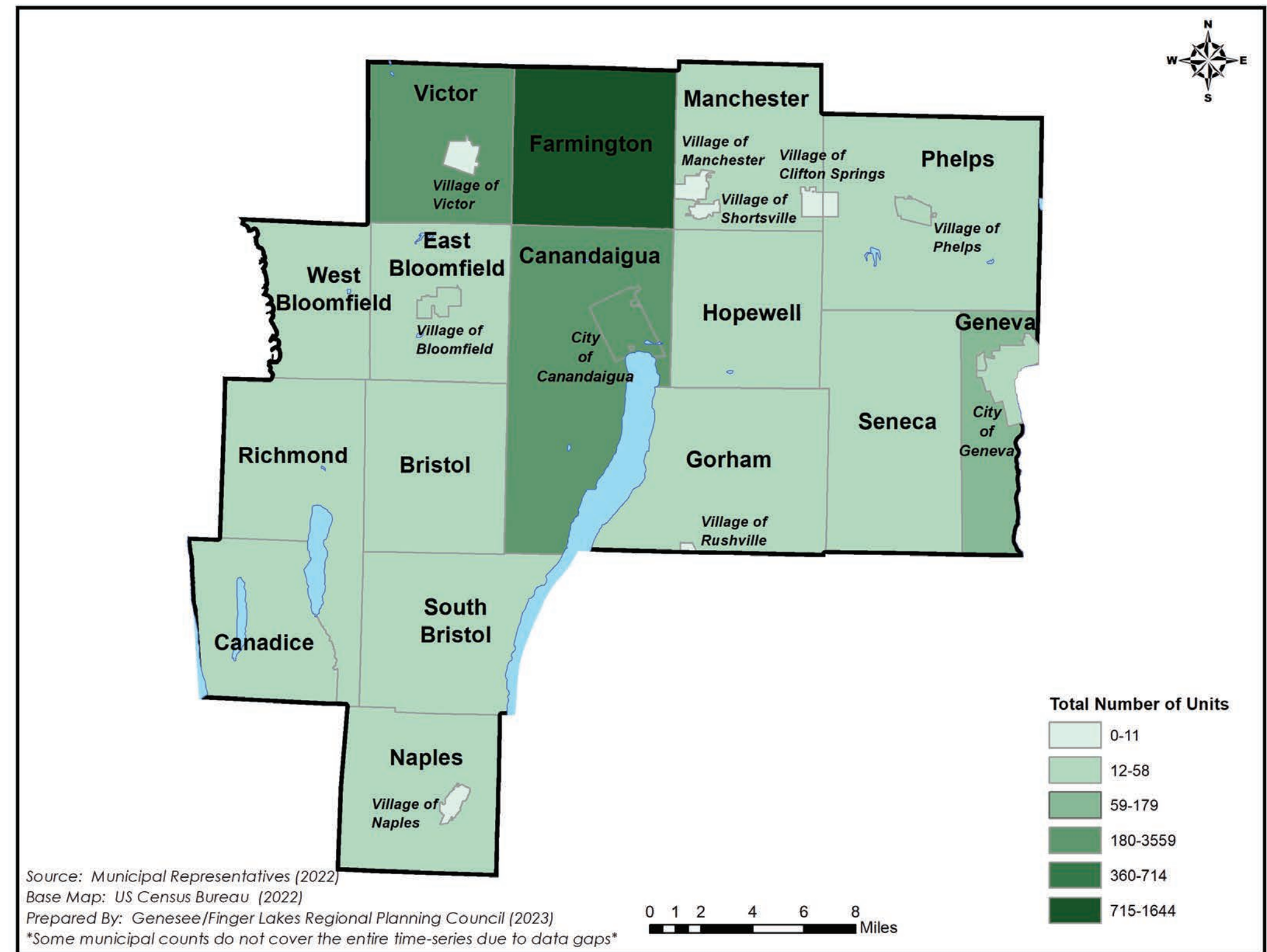

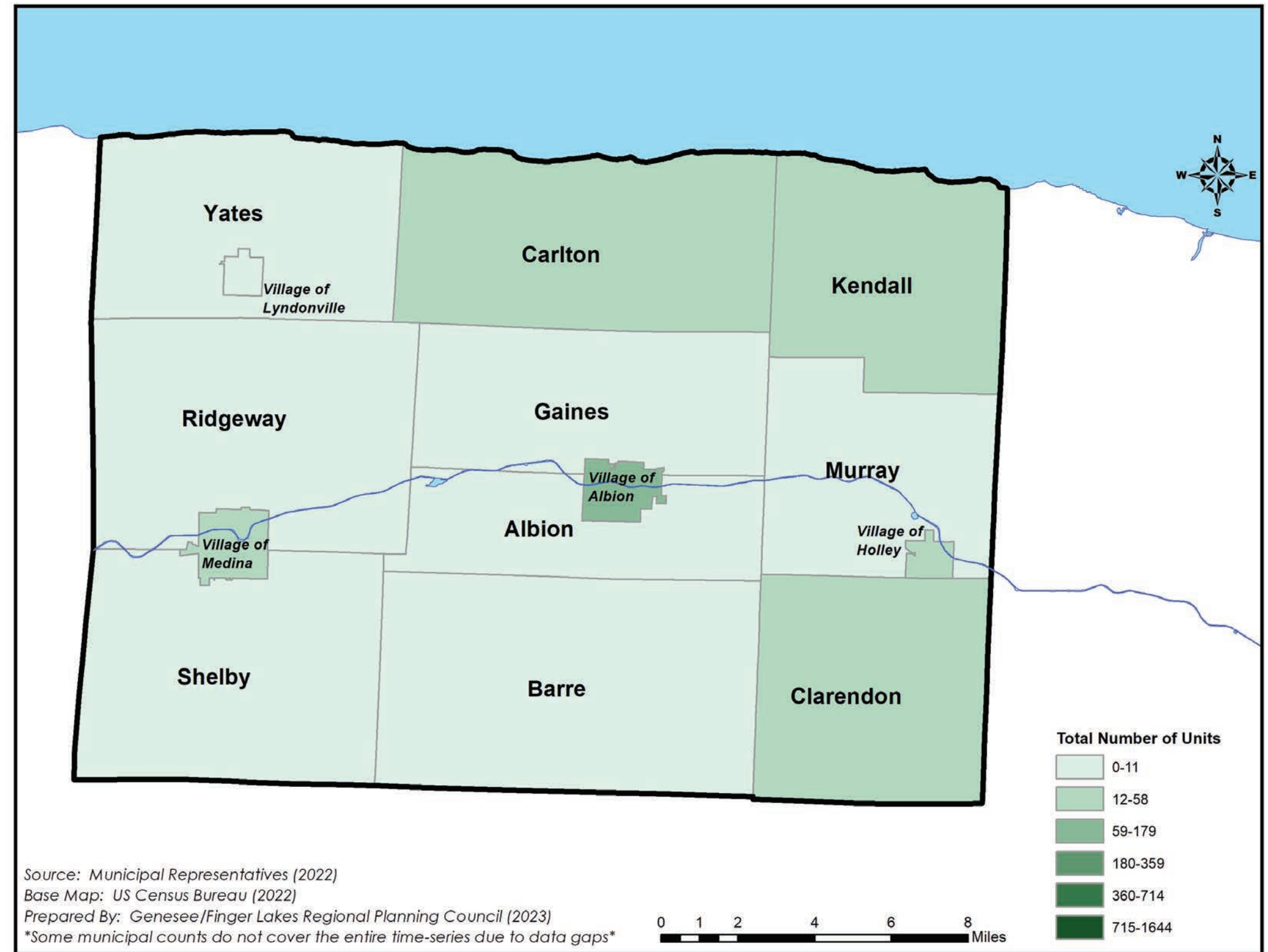

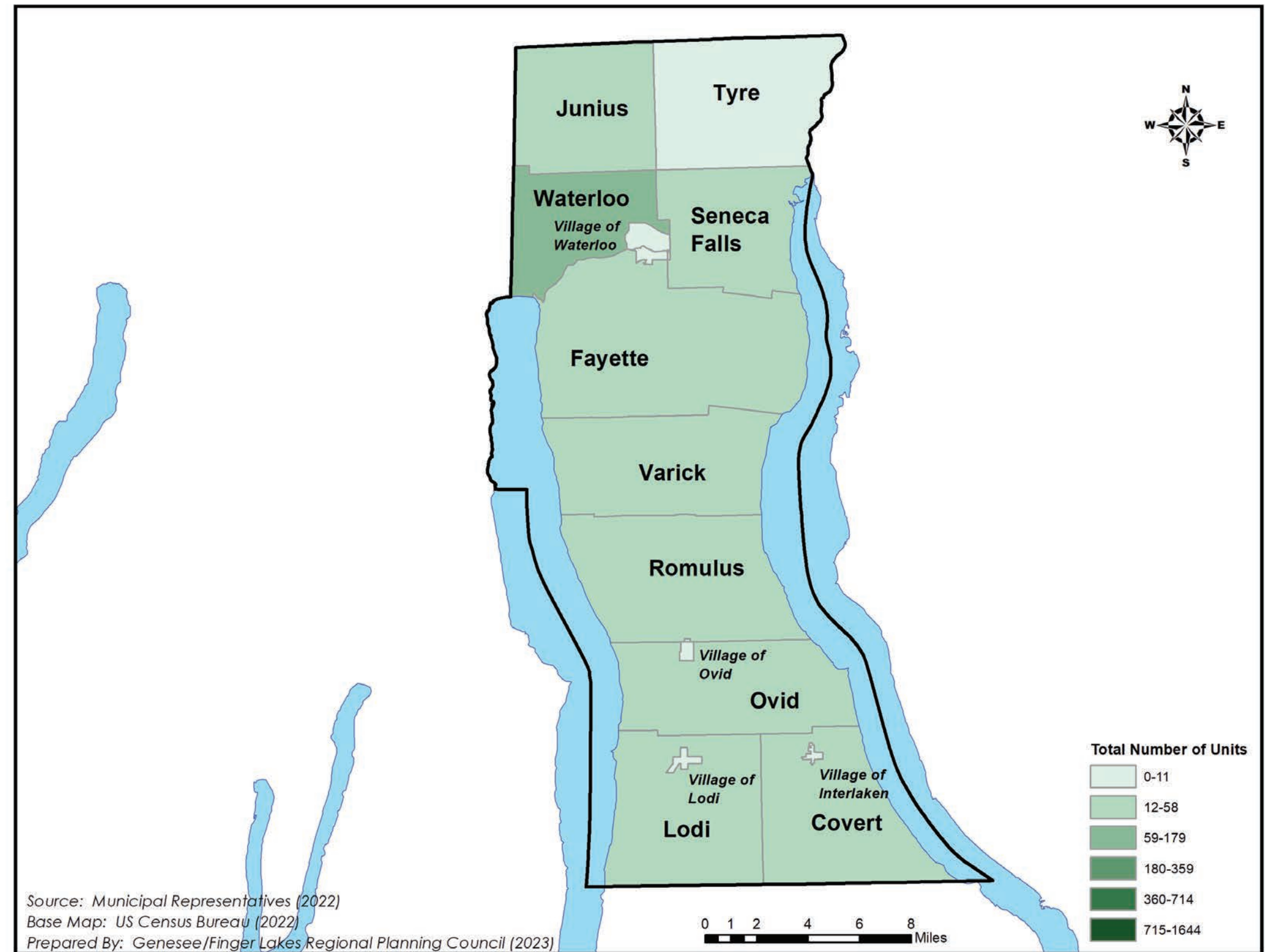

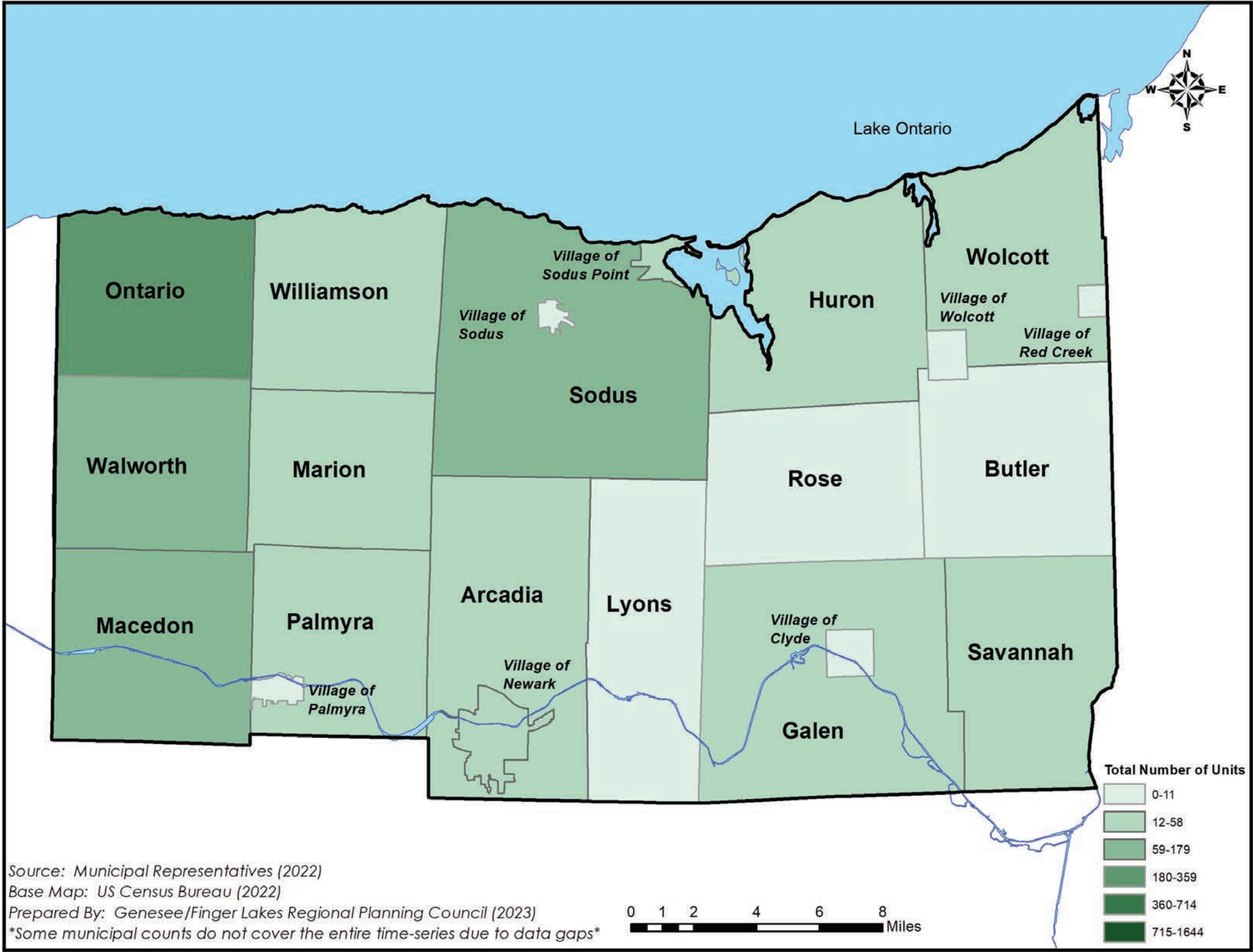

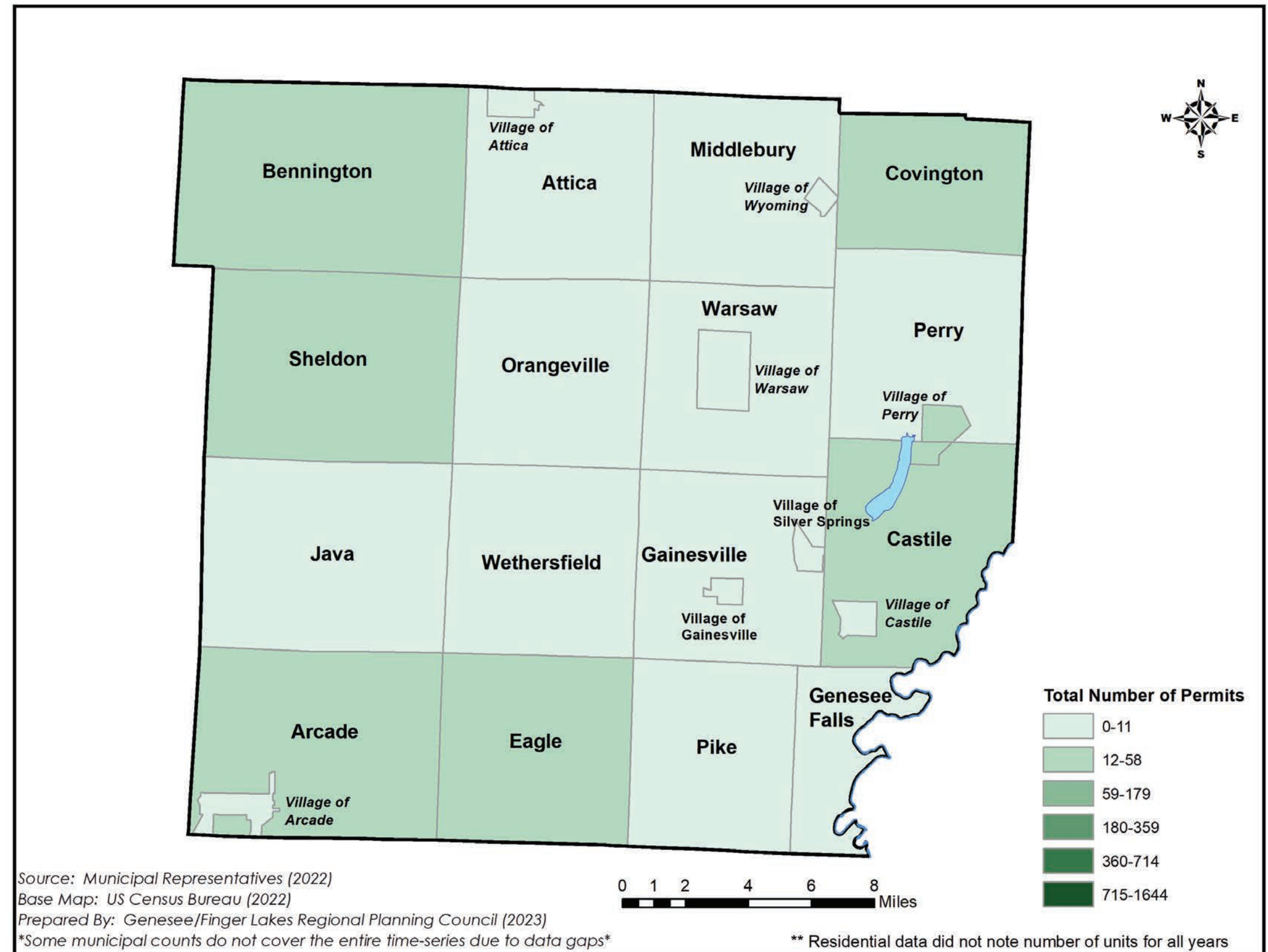

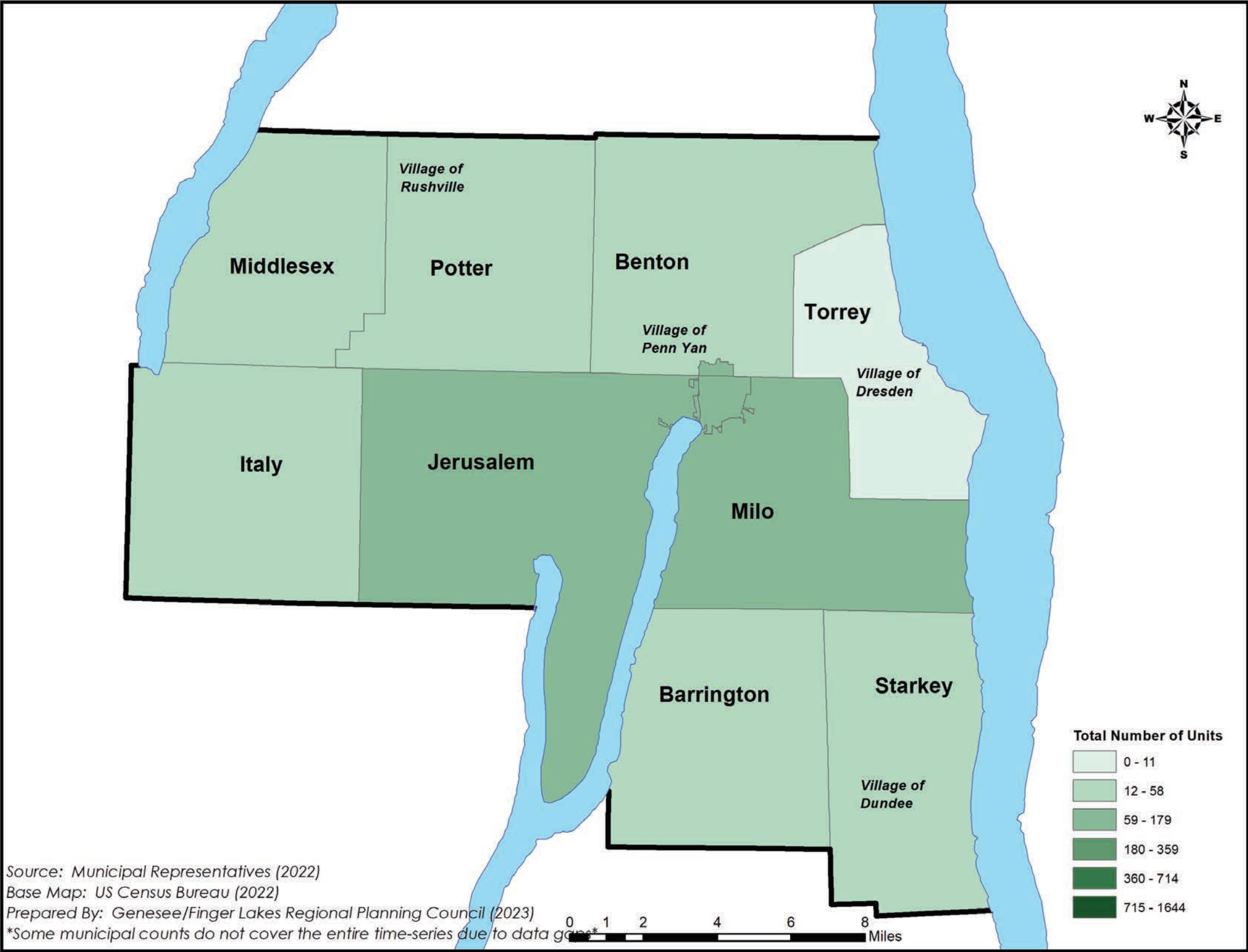

5. Metropolitan Planning Area (MPA)

The MPA is comprised of 56 municipalities with two additional villages bisected by the MPA boundaries, the Villages of Clifton Springs and Rushville in Ontario County.

Residential:

▪ Within the MPA, there was a total of 1,074 residential permits issued in 2022. The municipalities with the highest number of residential permits are the Town of Penfield in Monroe County with 106 permits followed by the Town of Webster with 87 permits and the Town of Farmington in Ontario County with 83.

▪ The number of residential units permitted in 2022 in the MPA shows a total of 1,989 units. The most permitted units were found in the Town of Henrietta with 656 and the next highest found in the Town of Perinton with 192 units both in Monroe County. The Town of Farmington permitted 139 units and the Town of Victor permitted 114 units, both in Ontario County.

▪ The top municipality in Ontario County was the Town of Farmington with 83 permits representing 139 units.

▪ The top municipality in Wayne County was the Town of Walworth with 42 residential permits representing 42 units in 2022.

▪ The top municipality in Livingston County was the Town of Avon with 36 residential permits for 36 units in 2022.

Single Family Residential:

▪ The top three municipalities with reported single family/mobile/manufactured home permits in 2022 were the Town of Penfield (99), the Town of Webster (87), and the Town of Greece (73) in Monroe County.

▪ The top three municipalities with single family/mobile/manufactured home permits outside of Monroe County in 2022 were the Town of Farmington (65) and the Town of Victor (57) in Ontario County and the Town of Walworth (42) in Wayne County.

Multi-Family Residential:

▪ The top three municipalities permitting multi-family residential units in 2022 are the Town of Henrietta, Monroe County, with 19 permits representing 616 units, the Town of Farmington, Ontario County, issued 15 permits for 68 units, and the Town of Perinton, Monroe County, issued 14 permits for 182 units.

▪ The top three municipalities' permitted units for multi-family residential in 2022 are the Town of Henrietta with 616 units, the Town of Perinton with 182 units, both in Monroe

County, and the City of Canandaigua, Ontario County, with 120 units.

Subdivisions:

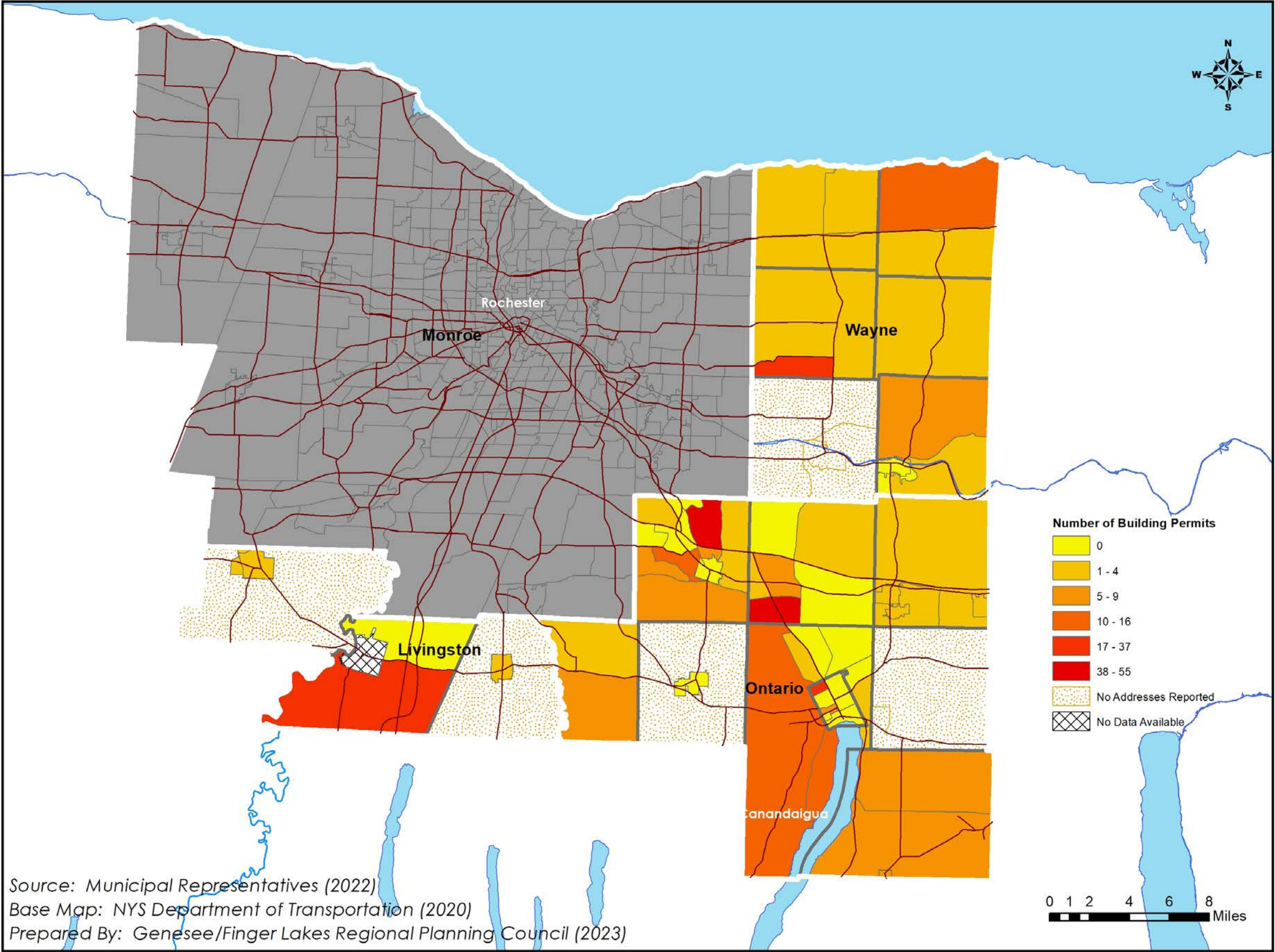

Addresses of residential building permits issued in 2022 were collected from municipalities located within the Metropolitan Planning Area (MPA) outside of Monroe County. Addresses were then geocoded using Geographic Information System software to determine which Transportation Analysis Zone (TAZ) each permit was located in. Some addresses did not geocode accurately and were manually moved to the approximate location based on a review of aerial imagery. And not all municipalities reported addresses for the building permits. As the transportation analysis zones tend to follow road boundaries this should not impact the accuracy of the number of permits per transportation analysis zone.

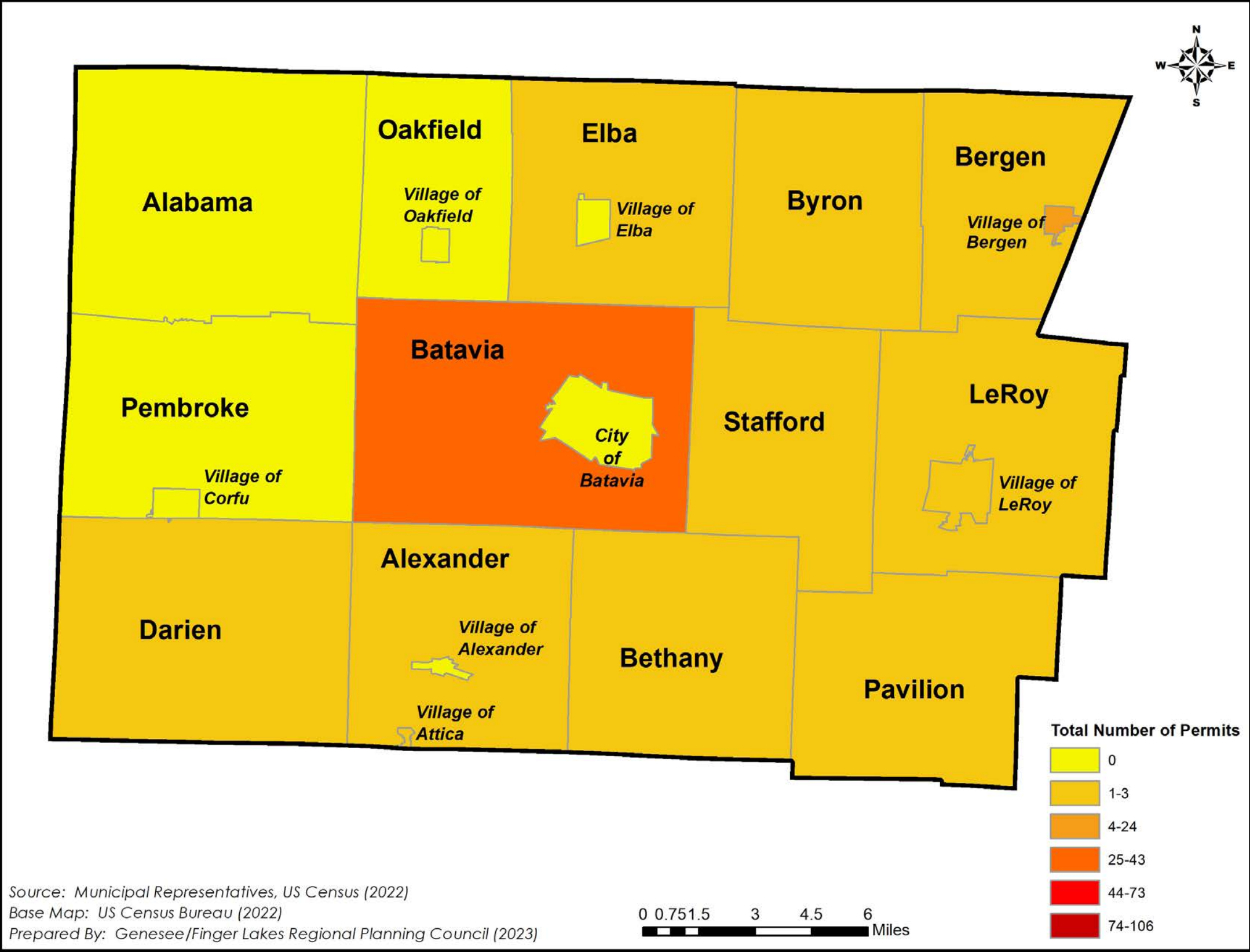

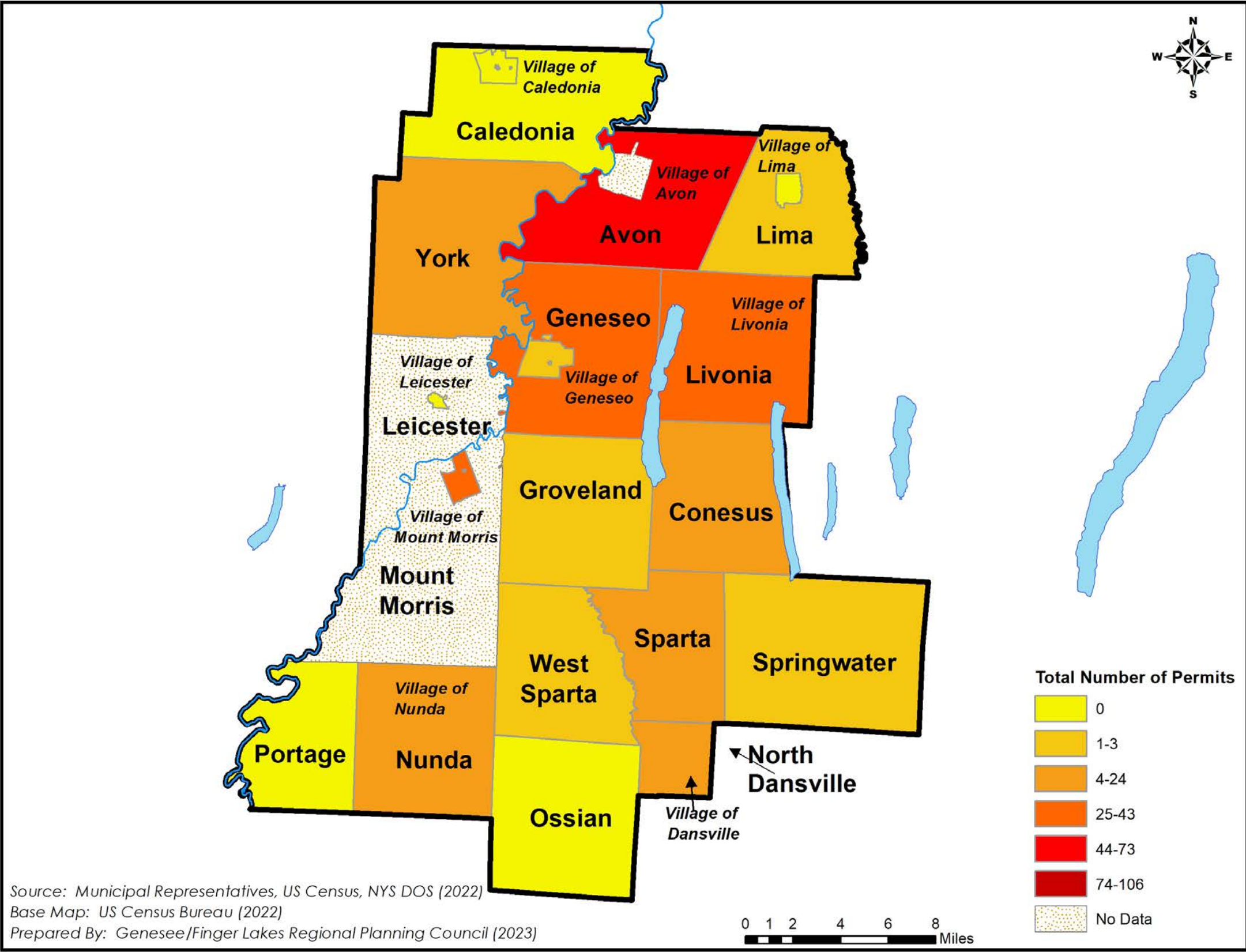


Map 31 | Metropolitan Planning Area | Number of Residential Unit Permits outside of Monroe County

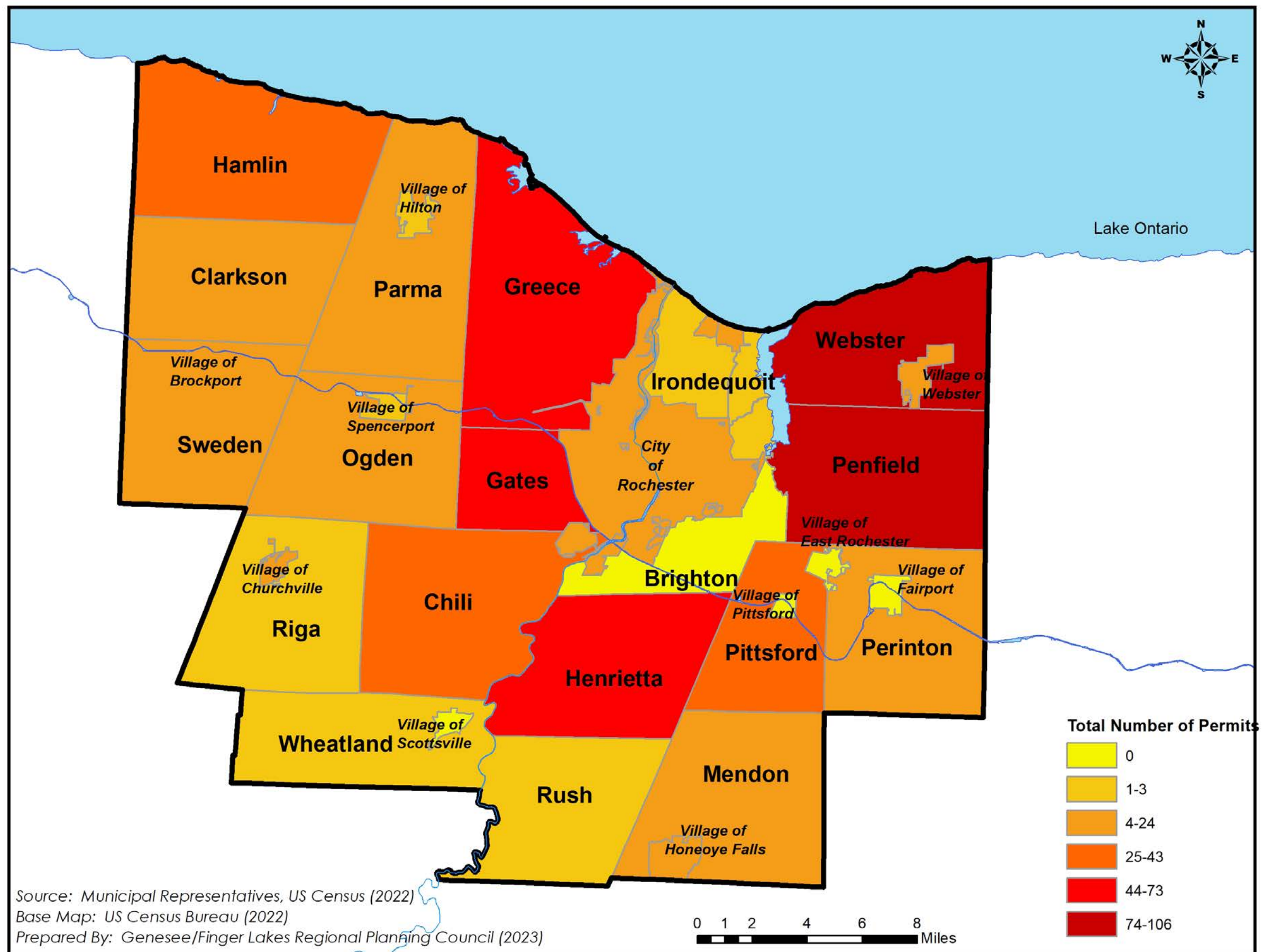

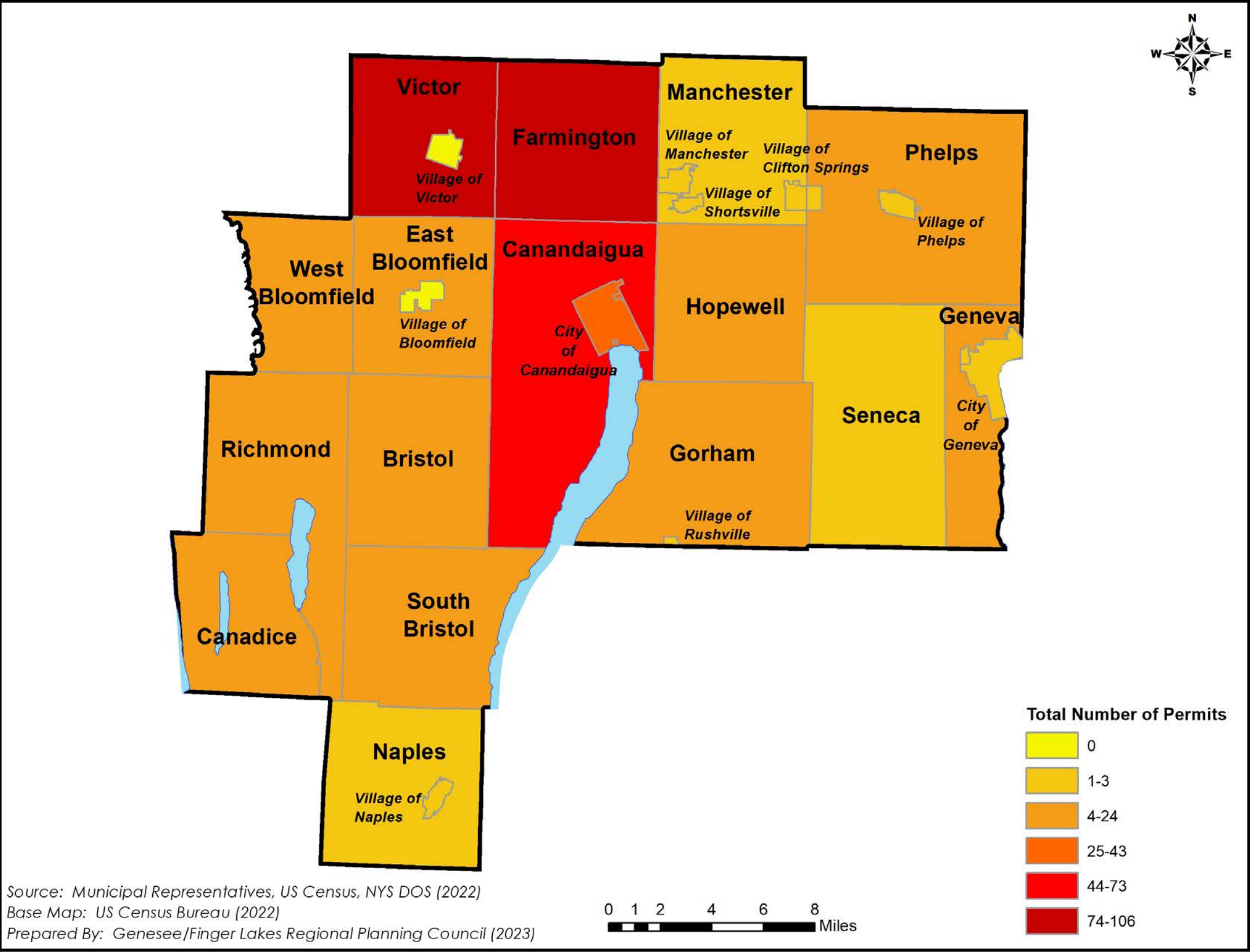
Map 10 | Number of Residential Permits (2022) | Genesee County



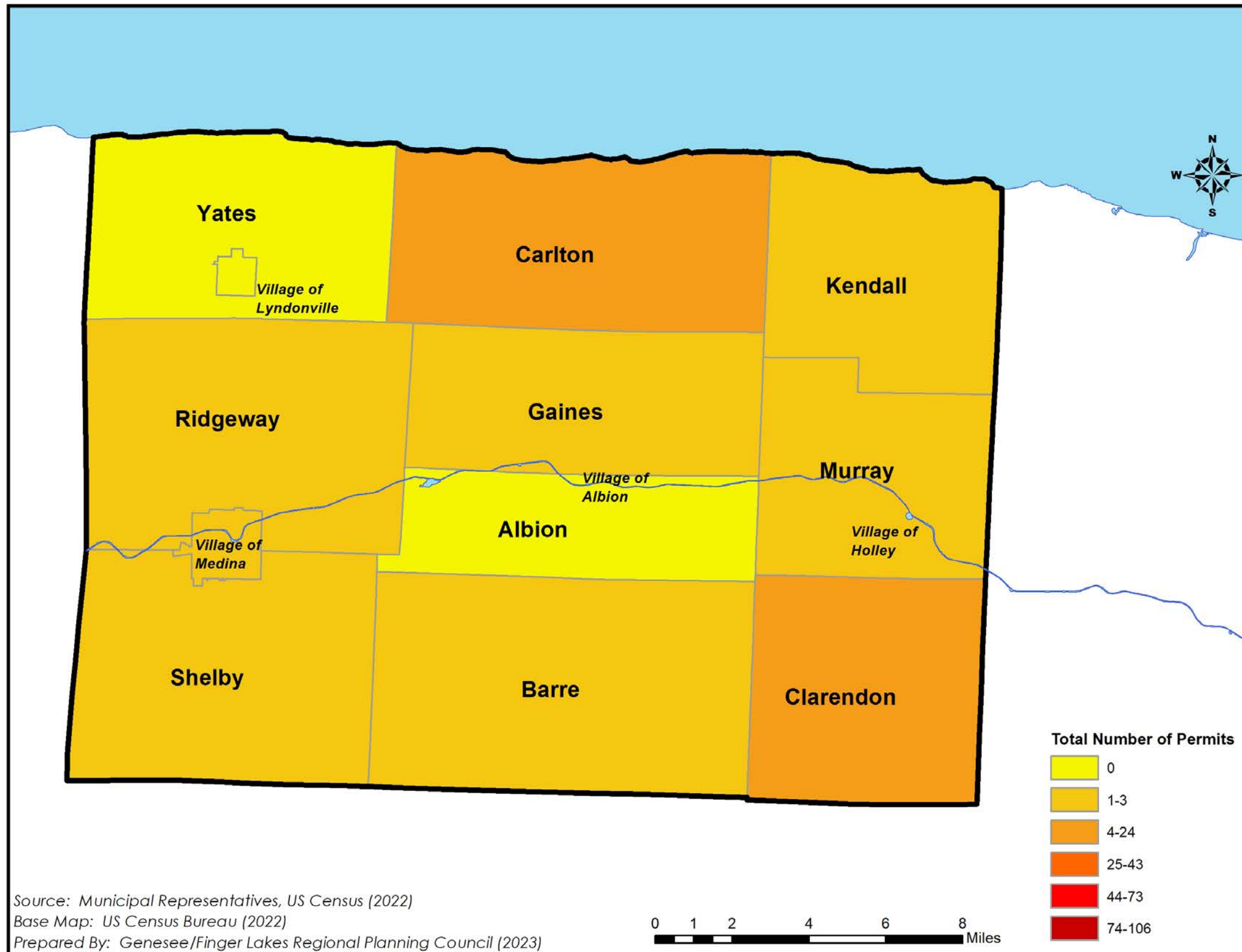
Map 11 | Number of Residential Permits (2022) | Livingston County



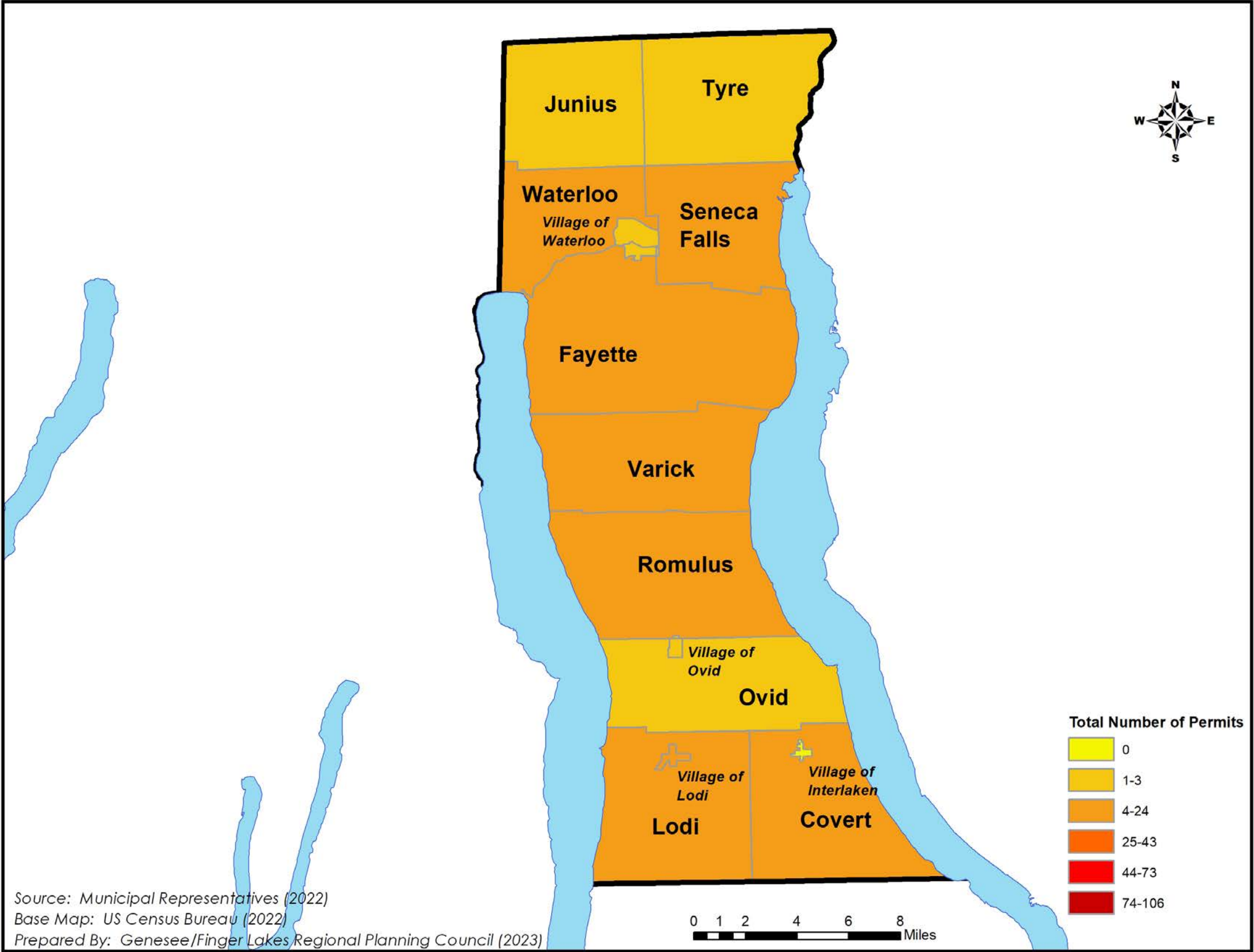
Map 12 | Number of Residential Permits (2022) | Monroe County



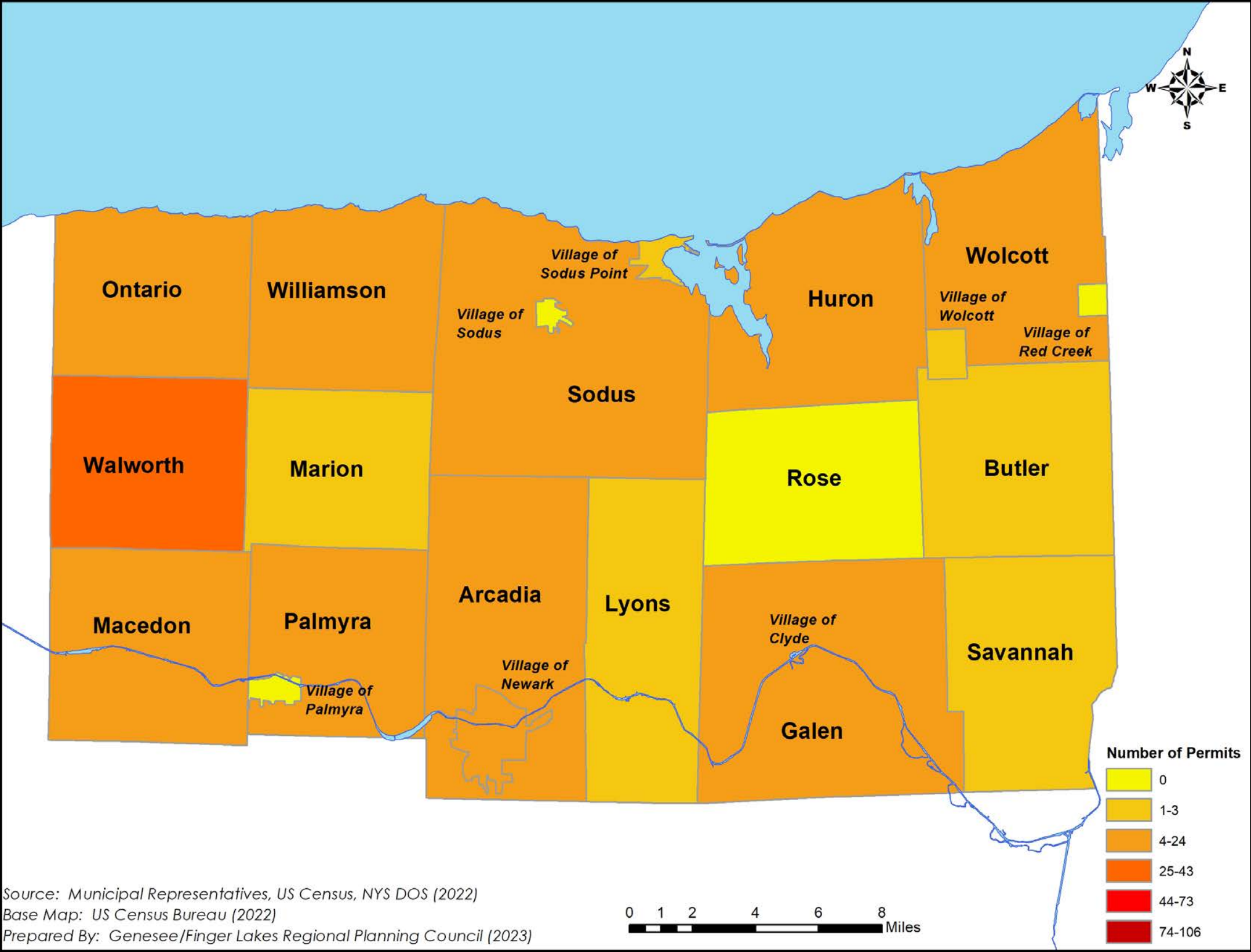
Map 13 | Number of Residential Permits (2022) | Ontario County



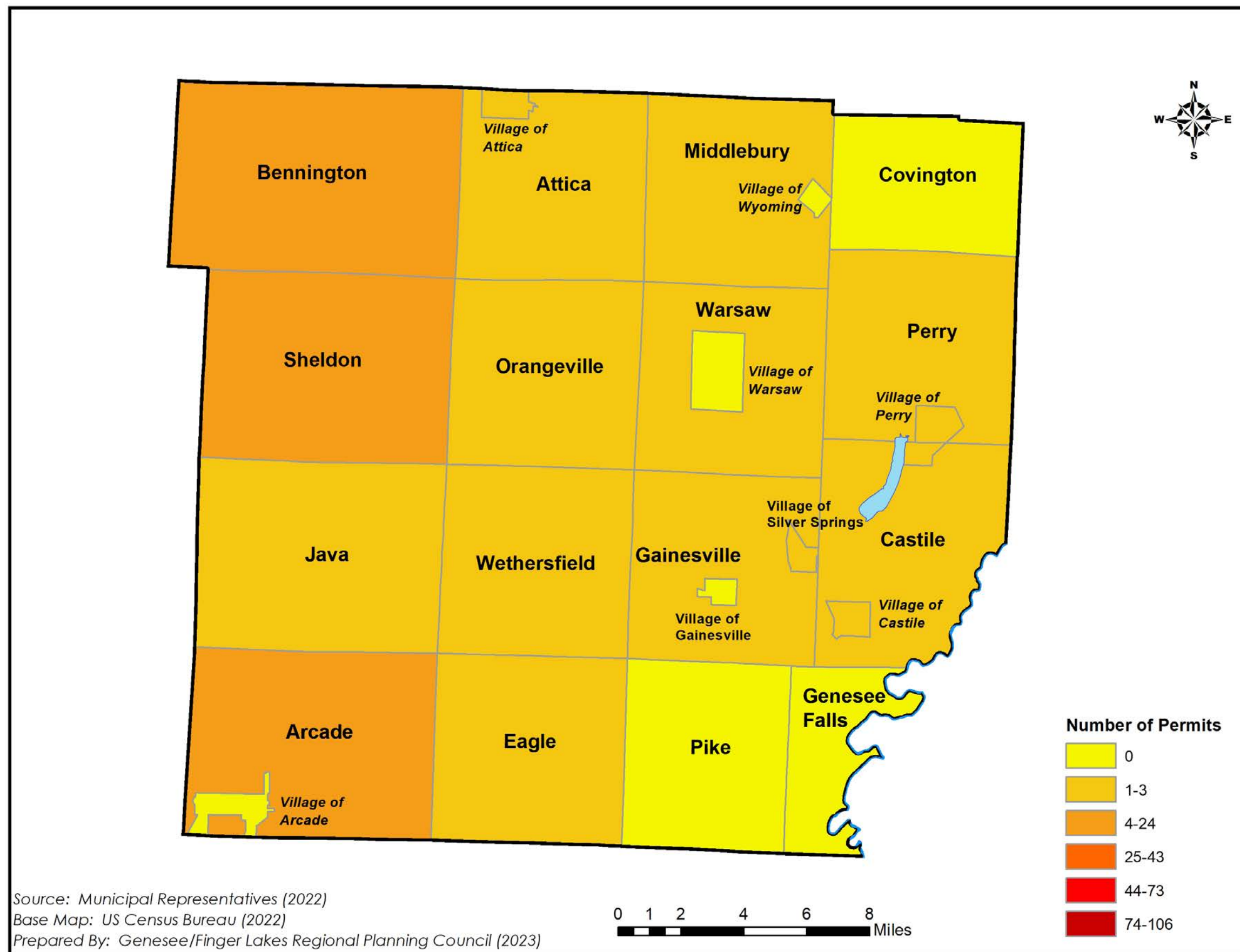
Map 14 | Number of Residential Permits (2022) | Orleans County



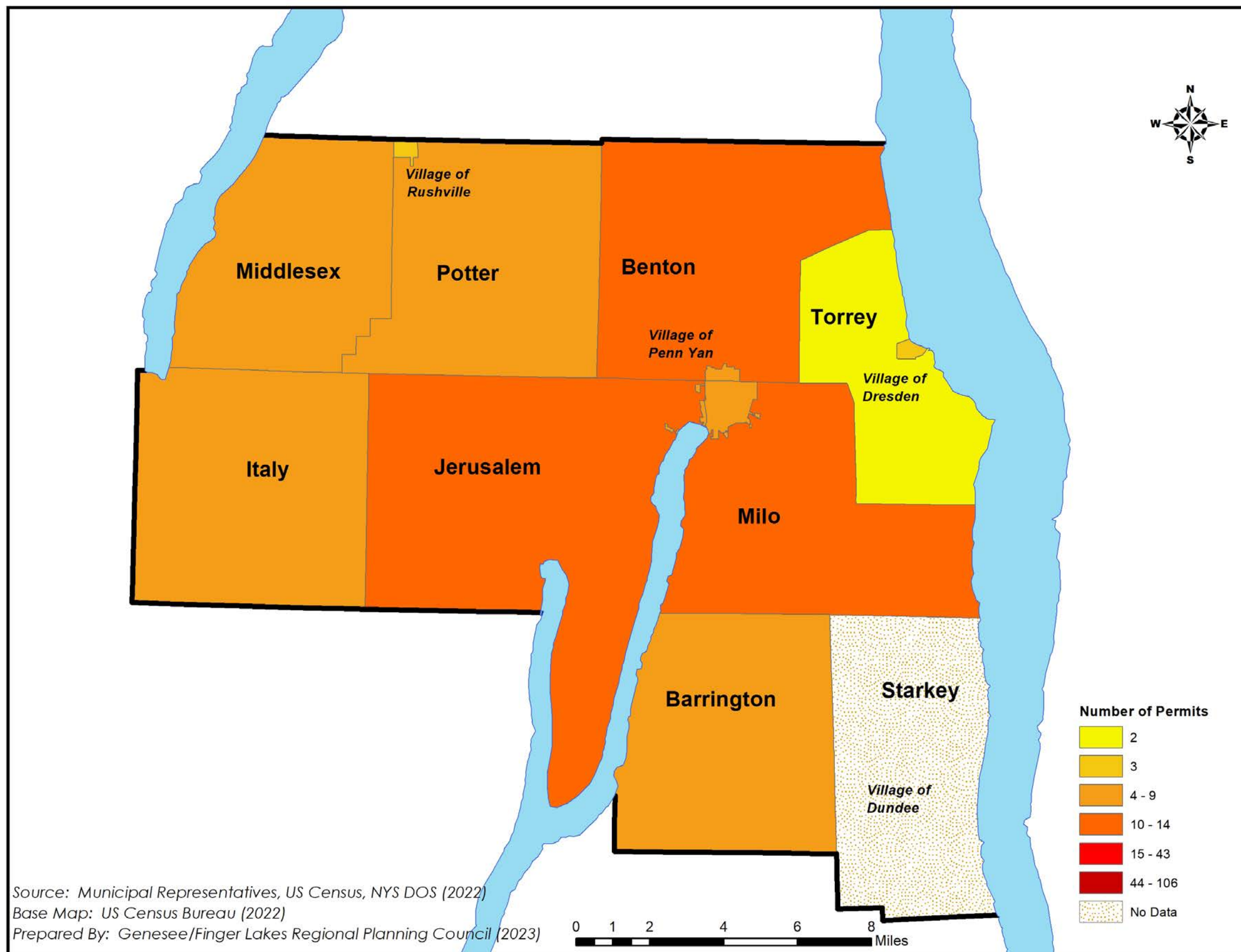
Map 15 | Number of Residential Permits (2022) | Seneca County



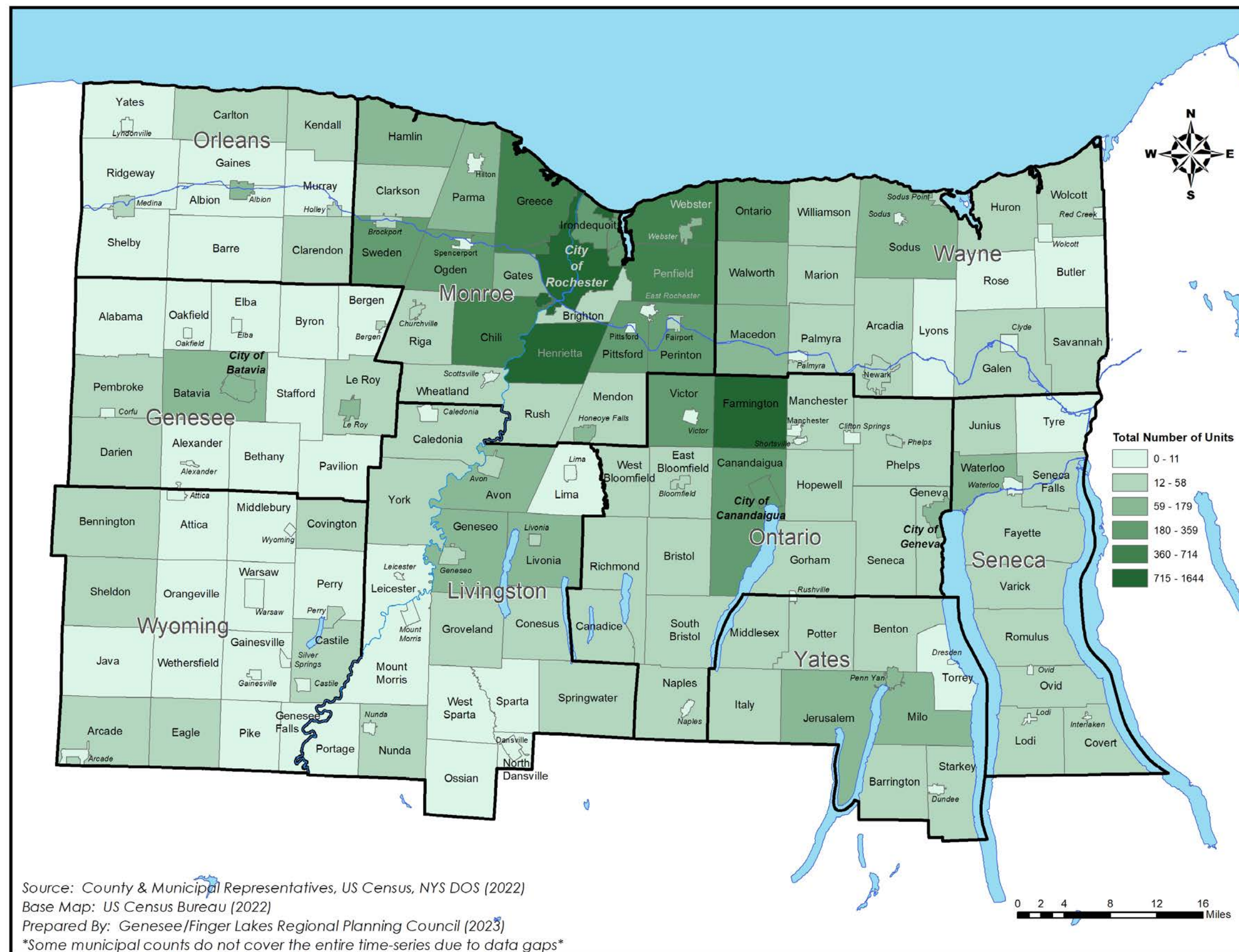
Map 16 | Number of Residential Permits (2022) | Wayne County



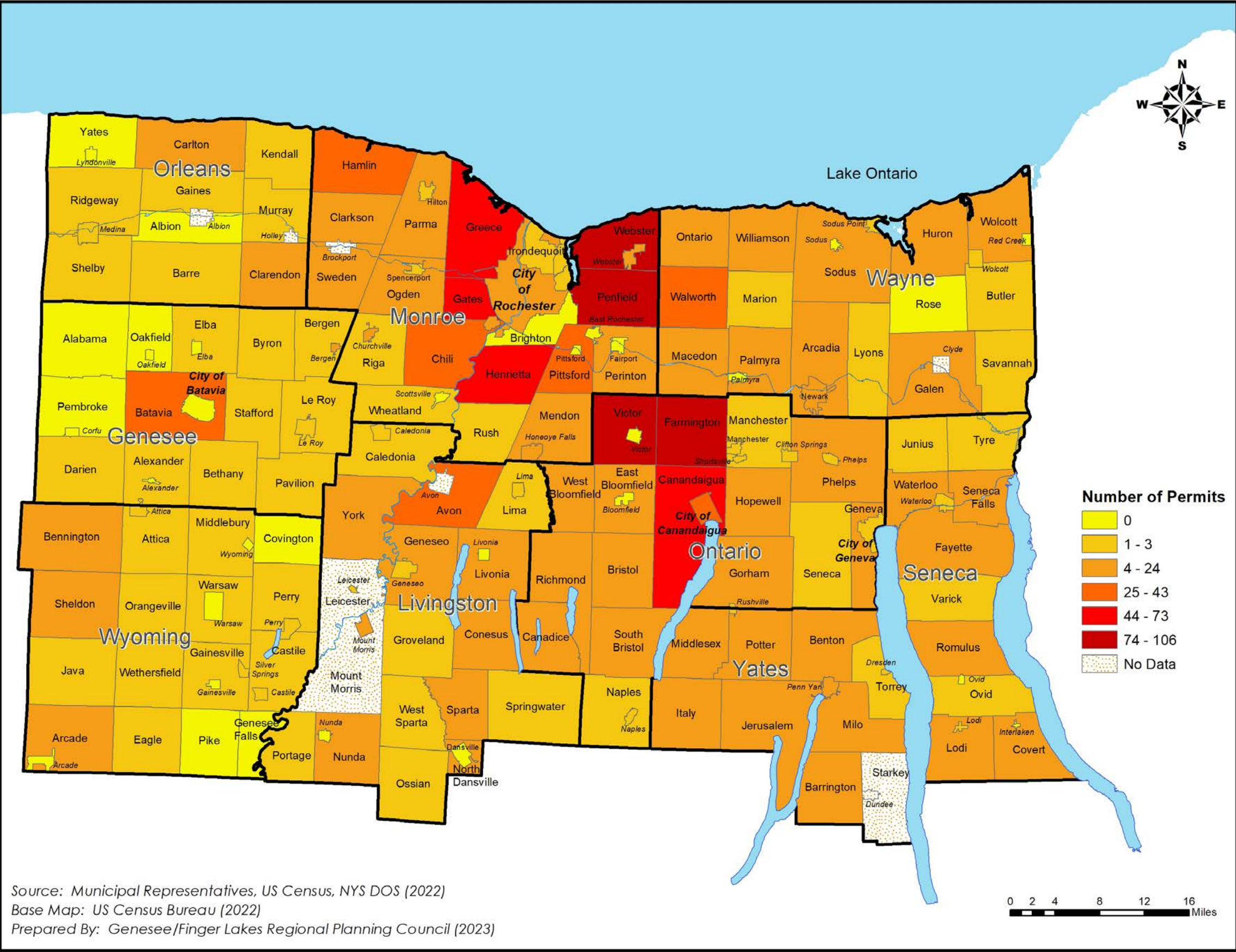
Map 17 | Number of Residential Permits (2022) | Wyoming County



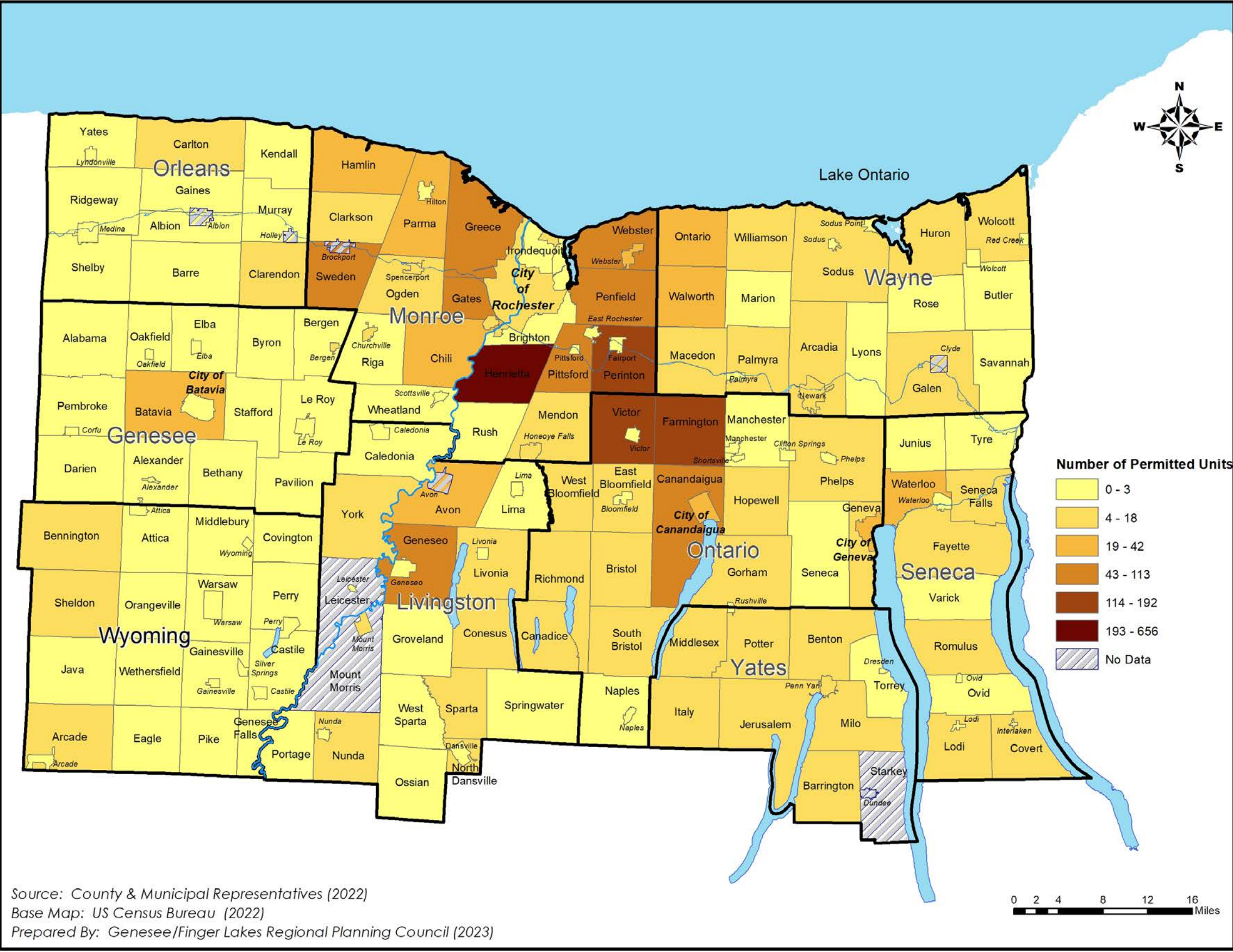
Map 18 | Number of Residential Permits (2022) | Yates County



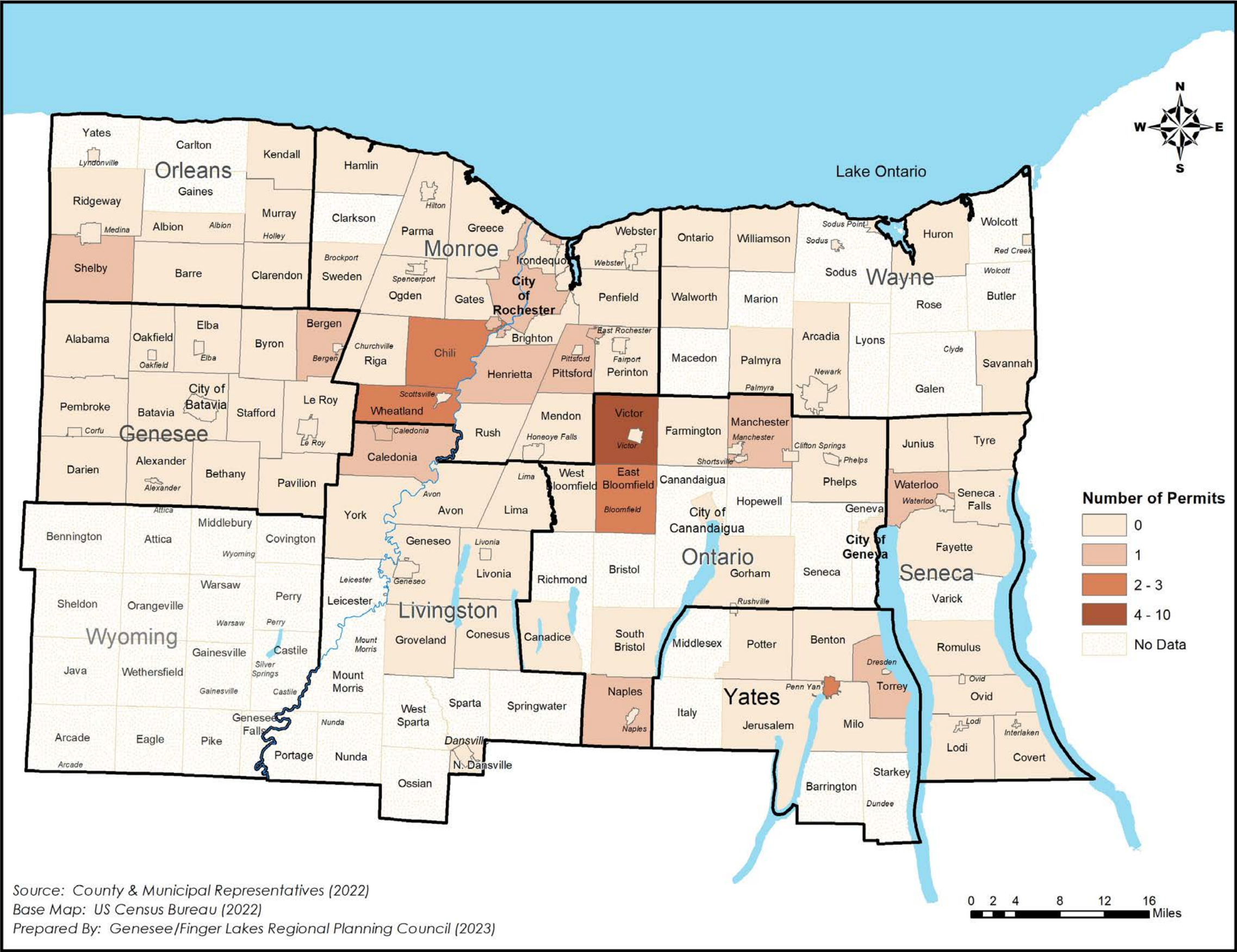
Map 19 | Genesee/Finger Lakes Region | Five-Year Analysis of Residential Permitted Housing Units



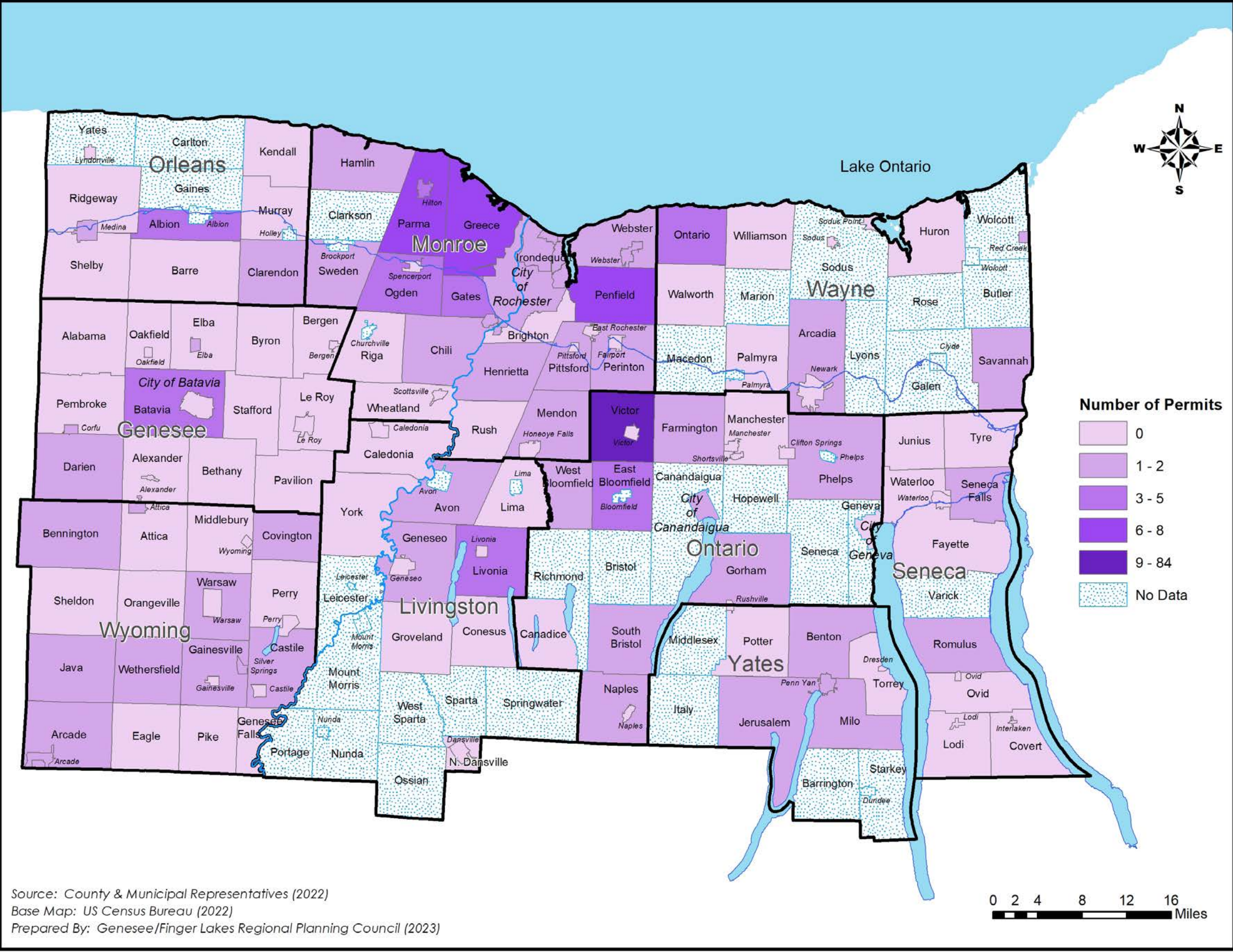
Map 20 | Genesee/Finger Lakes Region | Number of Residential Permits



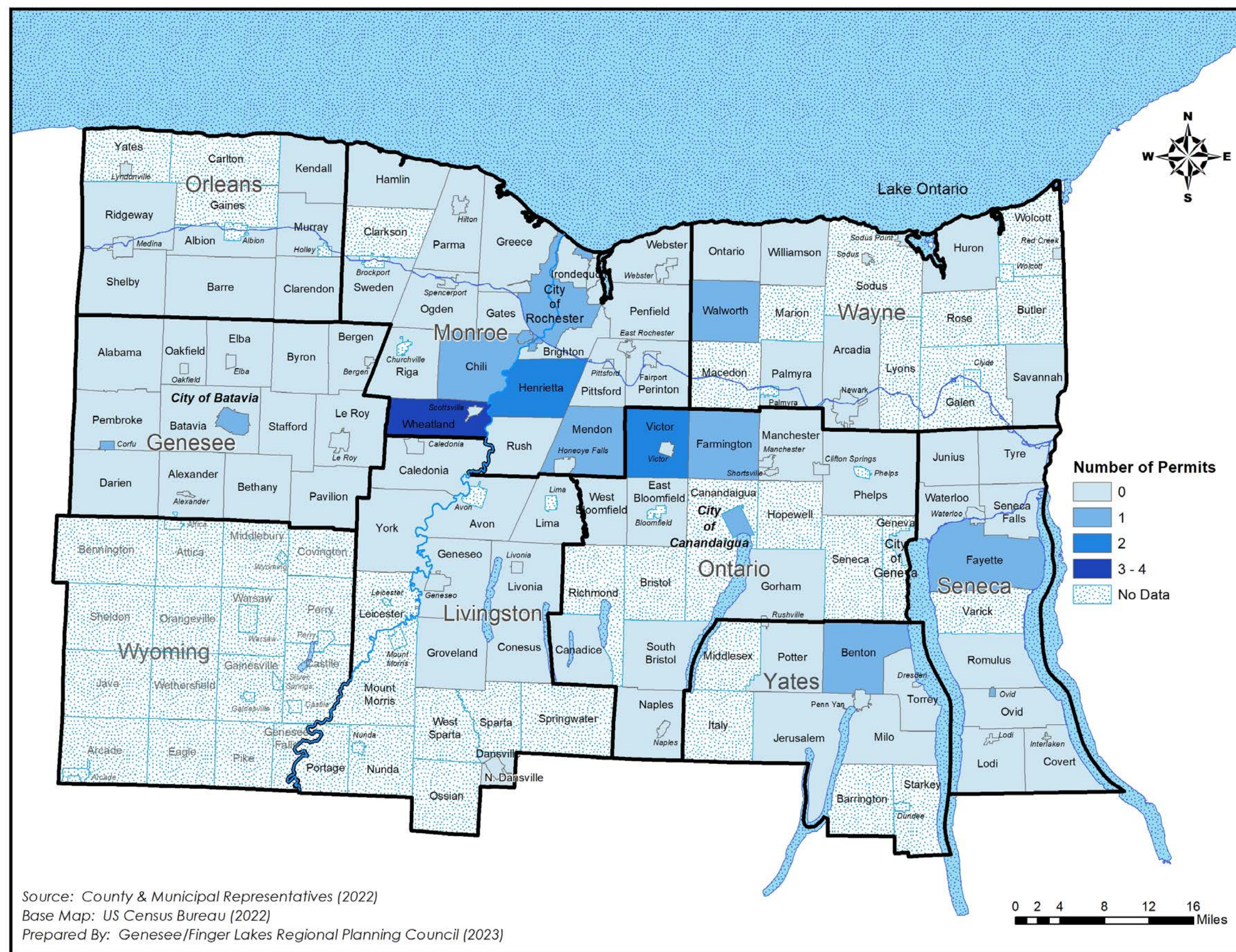
Map 21 | Genesee/Finger Lakes Region | Number of Residential Unit Permits



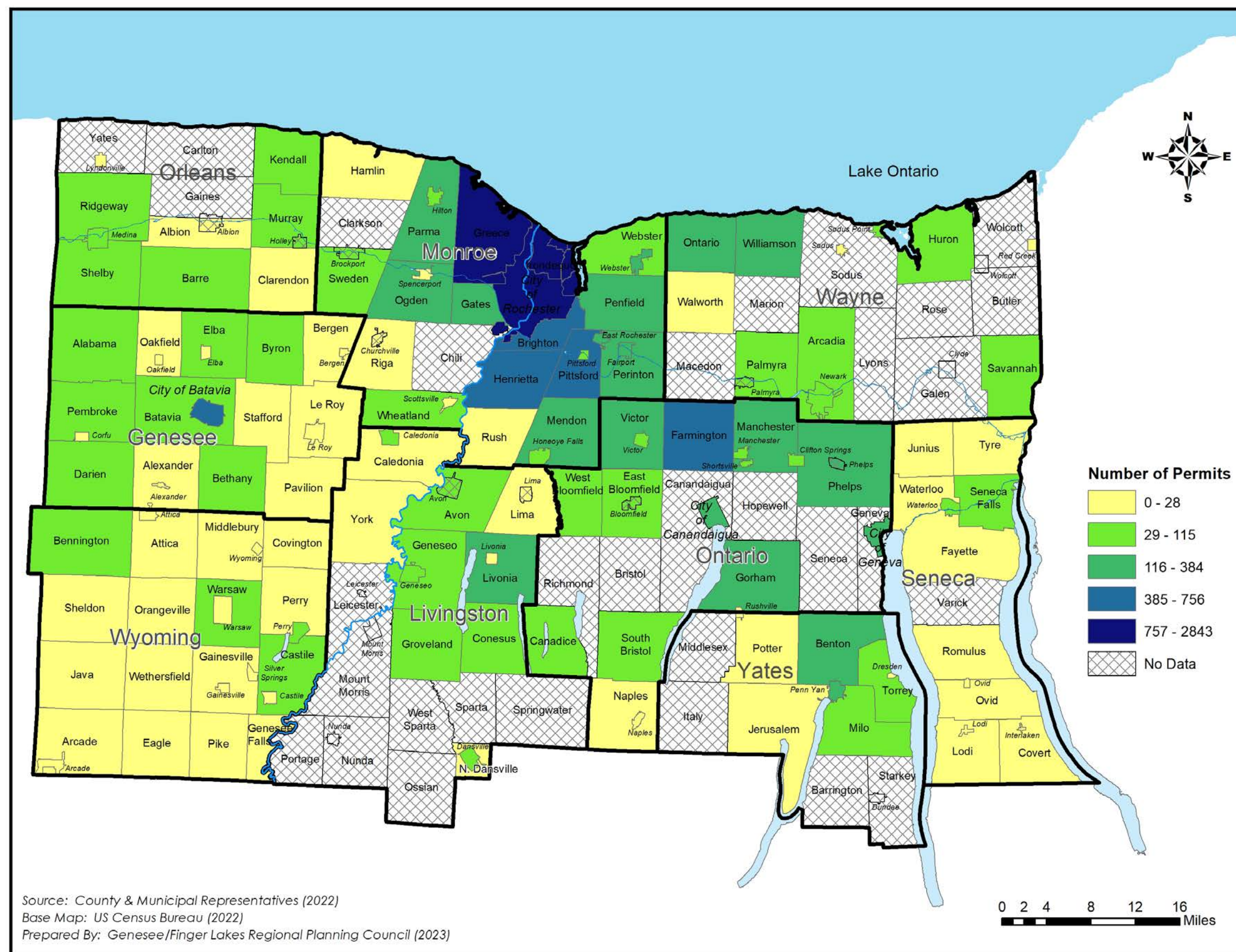
Map 22 | Genesee/Finger Lakes Region | Number of Industrial Buildings Permitted



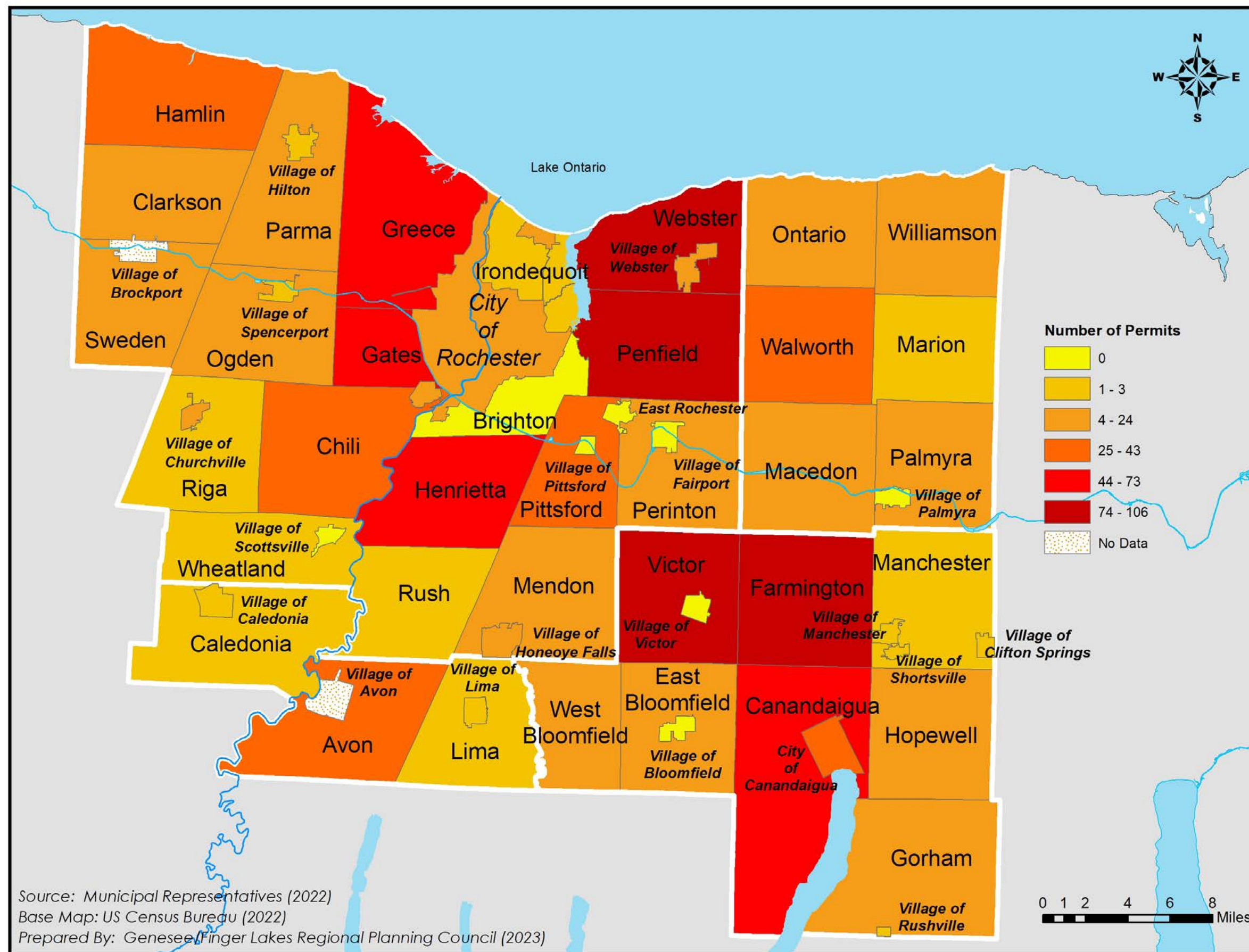
Map 23 | Genesee/Finger Lakes Region | Number of Commercial Buildings Permitted



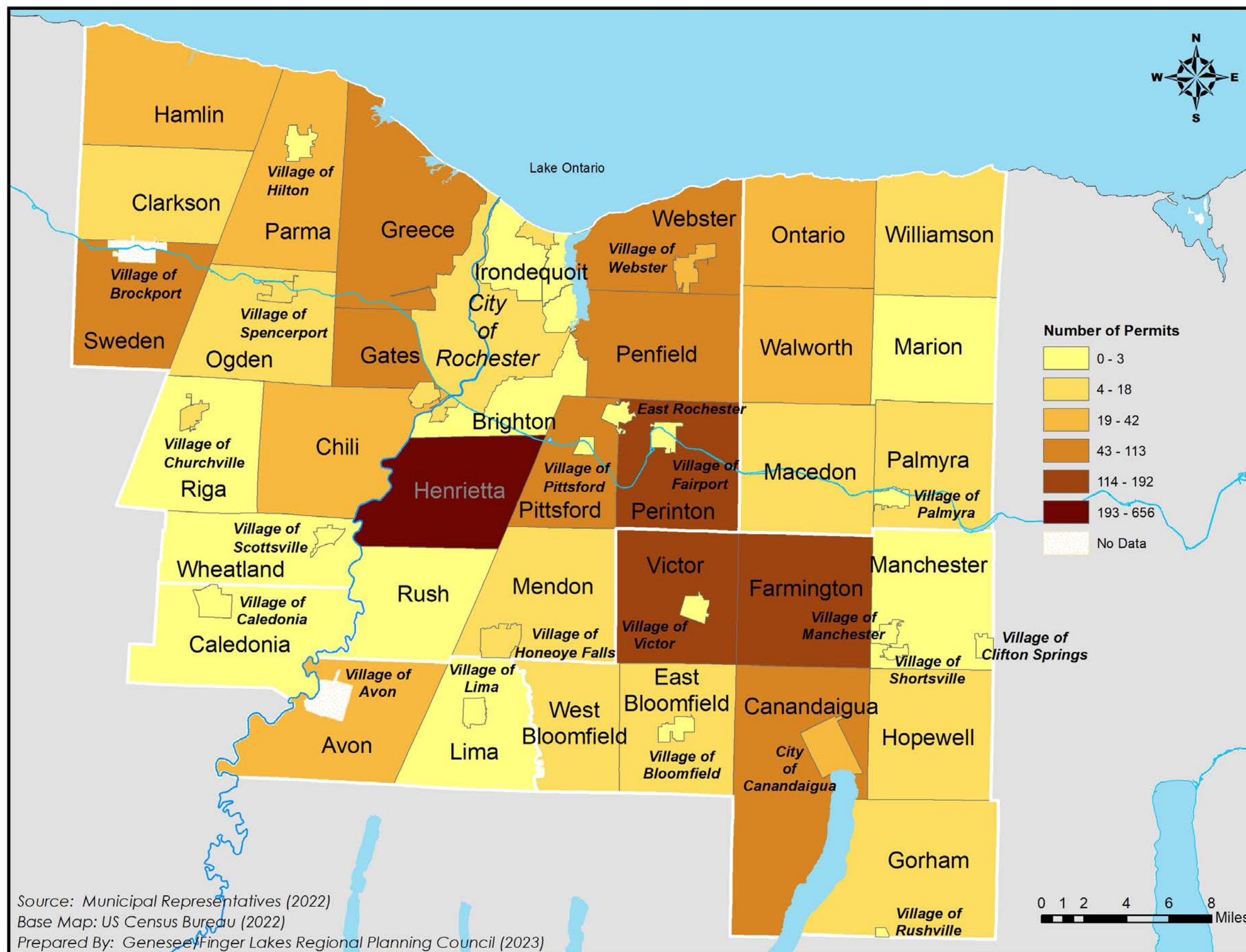
Map 24 | Genesee/Finger Lakes Region | Number of Community Service Buildings Permitted



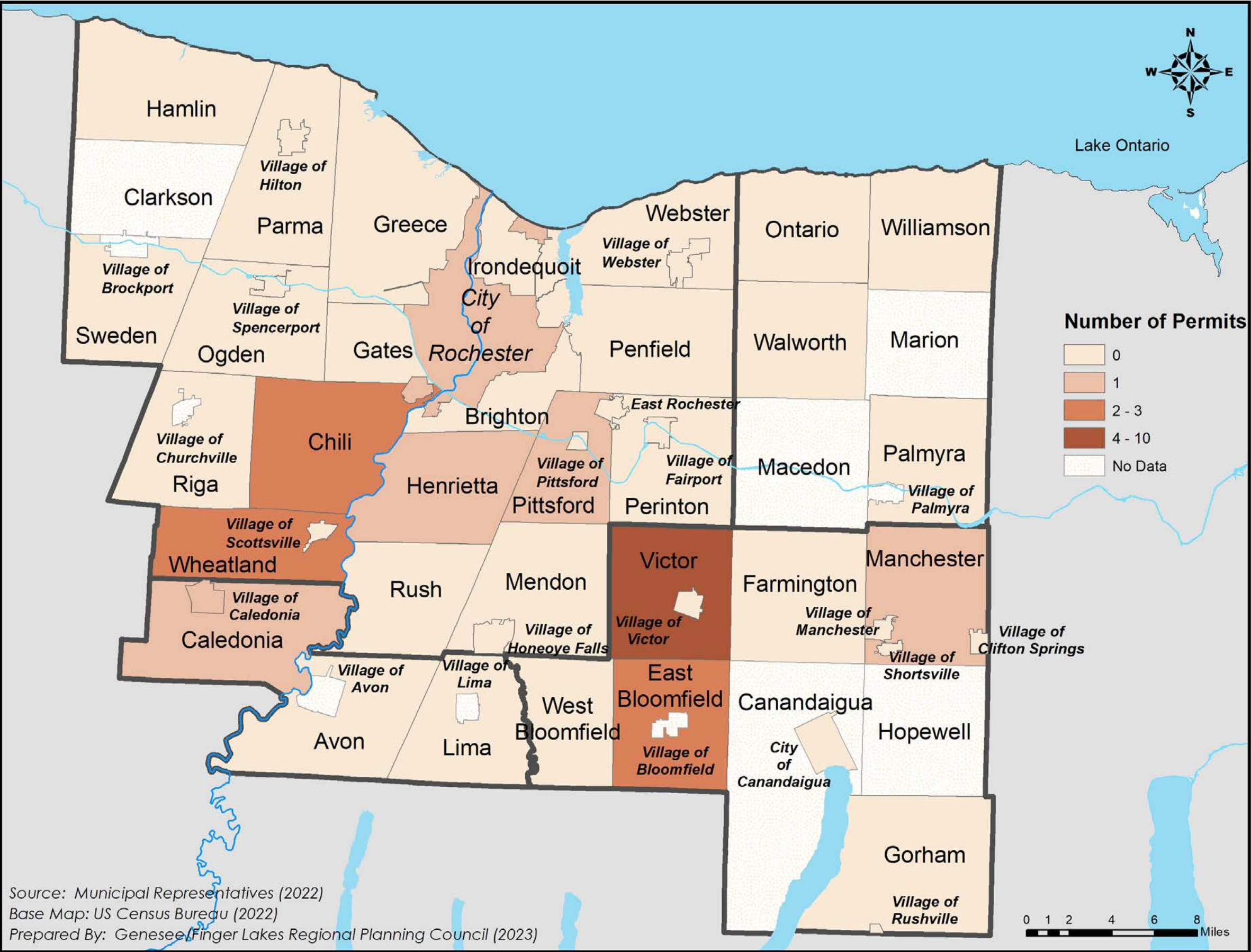
Map 25 | Genesee/Finger Lakes Region | Number of Remodel/Upgrade Permits



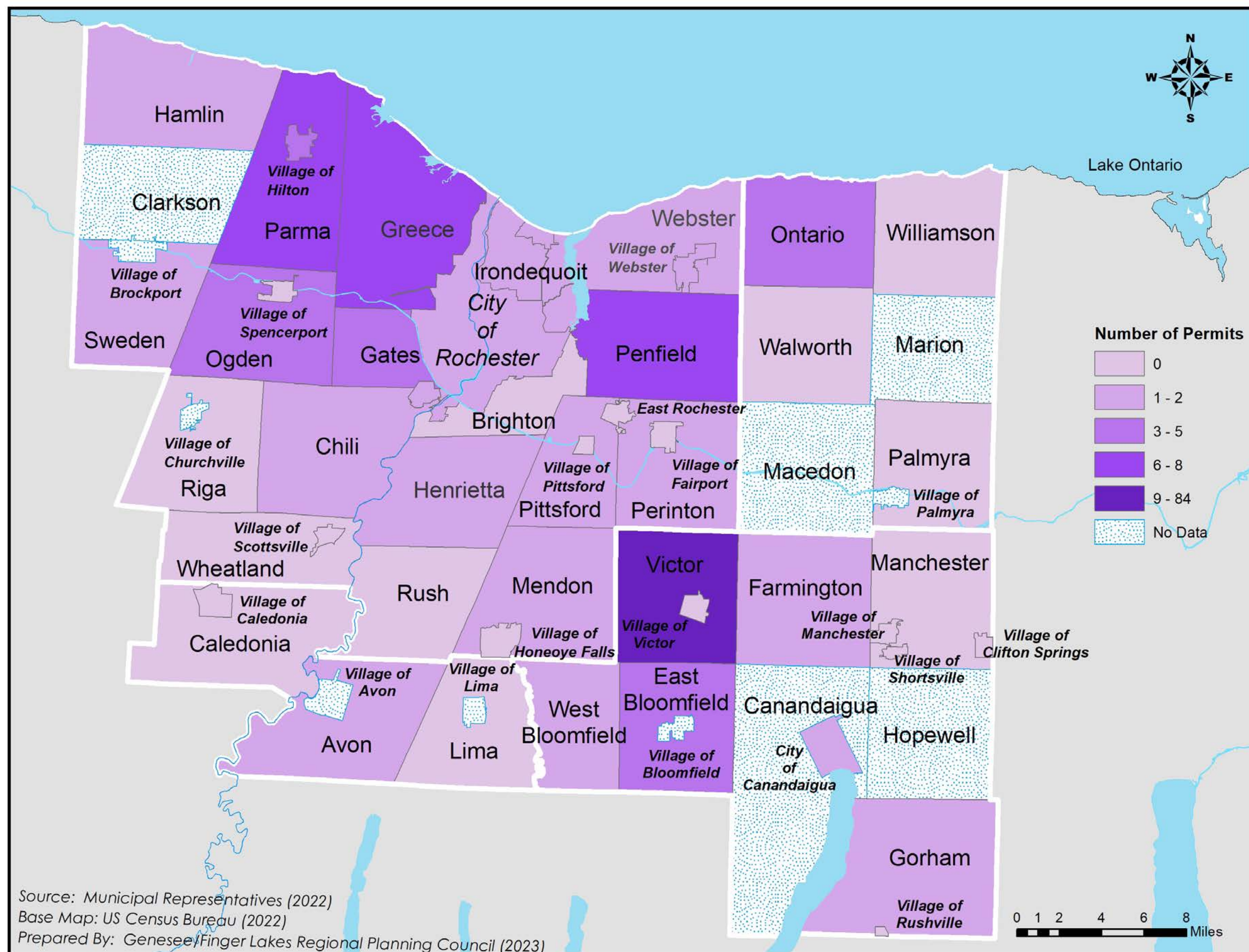
Map 26 | Metropolitan Planning Area | Number of Residential Permits



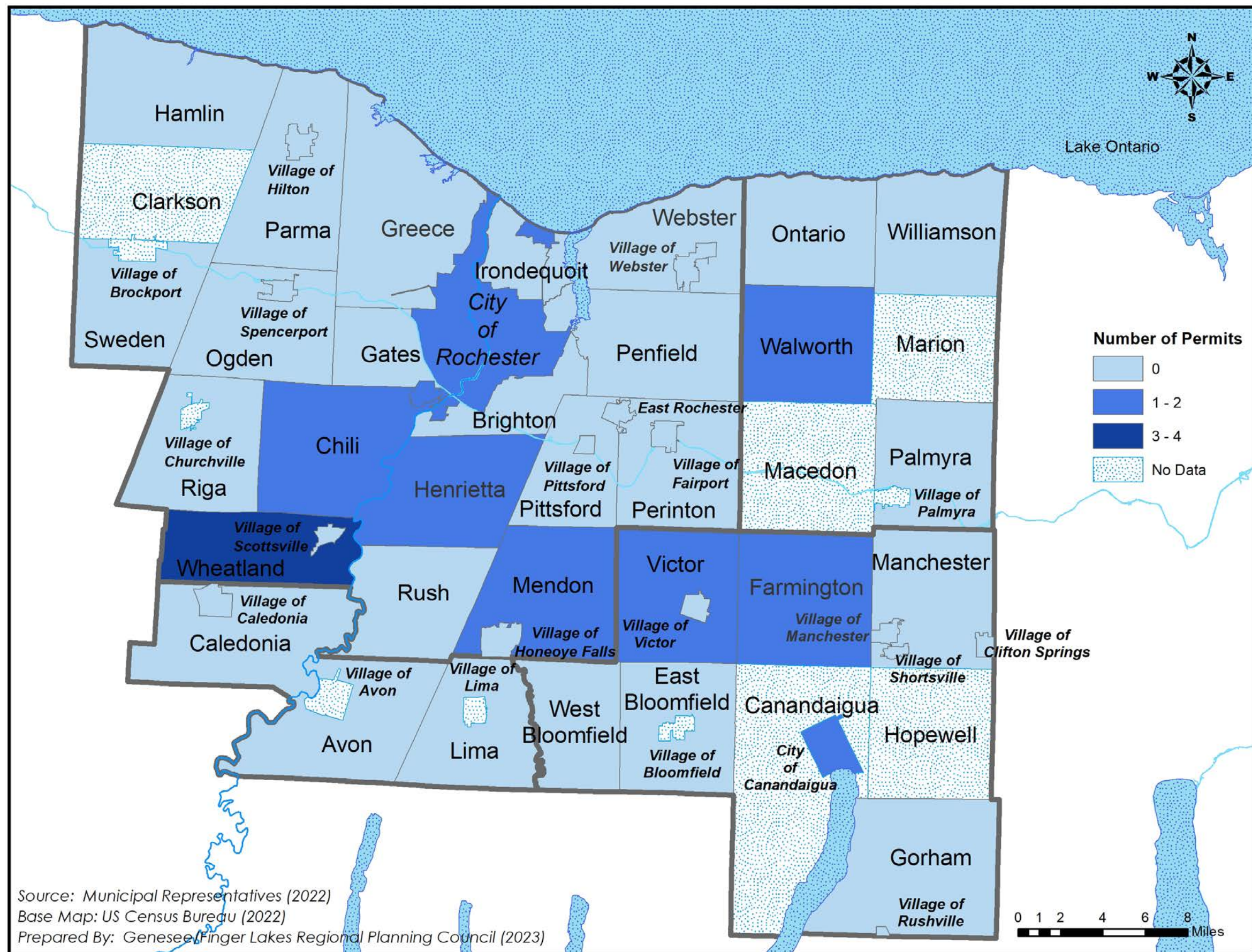
Map 27 | Metropolitan Planning Area | Number of Residential Unit Permits
