Increase the Total Cost from \$2,213,800 (\$1,748,500 Federal) to \$2,493,800 (\$1,972,500 Federal);

Increase a FFY 2026 Construction phase from \$1,906,100 (\$1,524,880 Federal) to \$2,186,100 (\$1,748,800 Federal);

The sources of existing Federal Aid are the BFP-Main and STBG-Flex Programs. Matching funds are provided by Orleans County.

Orleans County is requesting an increase in the project cost to cover the construction costs of adding a bridge (BIN 3361970) to the project. This bridge was previously removed from the Orleans County Bridge Preventive Maintenance No. 1 (PIN 40R007) project to prevent delays obtaining right-of-way for one location, out of seven, delaying

the whole project. The right-of-way for BIN 3311970 has now been obtained and the county is interested in advancing this project with federal aid resources. Funds are available in 2026 BFP-Main to cover this increase.

Decrease the FFY 2026 Right-of-Way Acquisition phase from \$7,000,000 (\$6,300,000 Federal) to \$5,500,000 (\$4,950,000 Federal);

Add a Supplemental FFY 2026 Preliminary Engineering phase of \$1,500,000 (\$1,350,000 Federal).

- 3. The source of Federal funds is the Highway Safety Improvement Program (HSIP);
- 4. The proposed change is described on the attached Project Detail Sheet;
- 5. The timing of this project is such that a modification of the *2026-2030 TIP* is now called for;
- 6. The GTC *TIP Procedures Manual* authorizes the Planning Committee to make TIP modifications of this nature;
- 7. The actions authorized under GTC Resolution No. 78-4 are consistent with an "Administrative Modification" as defined in 23 CFR 450.104; and
- 8. The Planning Committee is satisfied that this modification to the *2026-2030 TIP* is within the limits of reasonably expected funding resources and is consistent with the Long Range Transportation Plan.

- 1. That the Genesee Transportation Council modifies the *2026-2030 TIP* by decreasing the cost of the Corridor Safety Enhancement Project, Rt 15 from Jefferson Rd to I-390 project (PIN 401547) and will update the existing TIP table accordingly, and;
- 2. That this resolution takes effect ten days after notification to the GTC Chairperson or upon notification that the GTC Chairperson does not plan to present this resolution to the GTC Policy Committee, whichever occurs first.
